TOWN AND COUNTRY PLANNING ACT 1962

The Minister of Transport hereby gives notice that she has made an Order under section 153 of the above Act entitled "The Stopping up of Highways (City and County of Bristol) (No. 10) Order 1966" authorising the stopping up of a length of Thomas Street, Bristol.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within six weeks of the 10th January 1967 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
