

## REGISTRAR OF RESTRICTIVE TRADING AGREEMENTS

### IN THE RESTRICTIVE PRACTICES COURT (IN ENGLAND AND WALES) 1967 PR. No. 10 (E. & W.)

In the Matter of the RESALE PRICES ACT 1964 and in the Matter of a Reference of ELECTRO-MECHANICAL DOMESTIC APPLIANCES and Related Classes of Goods

Notice is hereby given pursuant to Rule 8 of the Restrictive Practices Court (Resale Prices) Rules 1965 that on the 9th day of January 1967 there was issued out of the Restrictive Practices Court in England and Wales a Notice of Reference applying to the following classes of goods:

- (1) Electro-mechanical domestic appliances with self-contained electric motor within heading 85.06 of the Convention on Nomenclature for the Classification of Goods in Customs Tariffs (Cmnd. 1070) (hereinafter referred to as "the Brussels Nomenclature"); parts and attachments therefor classified under any heading of the Brussels Nomenclature;
- (2) Electrically-illuminated shaving mirrors of glass or base metal; rims of base metal or plastic for shaving mirrors, within headings 39.07, 70.09 or 83.12 of the Brussels Nomenclature;
- (3) Rechargeable electric torches under headings 85.10 of the Brussels Nomenclature; parts thereof, holders and attachments therefor, classified under any heading of the Brussels Nomenclature;
- (4) Electric massagers and applicators therefor under heading 90.18 of the Brussels Nomenclature; parts thereof classified under any heading of the Brussels Nomenclature.

Unless the Court otherwise directs these proceedings will take place in England

And notice is hereby further given that

- (a) any supplier of goods of any of the classes to which the said Notice of Reference applies who supplies such goods under arrangements for maintaining minimum prices on resale but who has not duly given notice to the Registrar pursuant to section 6 (2) of the said Act in respect of such goods
- (b) any retailer of goods of any of the classes to which the said Notice of Reference applies and
- (c) any trade association representing employees in the distributive trades

who wishes to be represented before the Court in the proceedings must notify the Registrar of Restrictive Trading Agreements at the address below in writing

within twenty-eight days hereof stating the nature of his interest and whether he supports or opposes the maintenance of minimum resale prices in respect of all or any of the goods to which the said Notice of Reference applies and giving the name of his Solicitor (if any) and an address in the United Kingdom at which documents may be served upon him.

### IN THE RESTRICTIVE PRACTICES COURT (IN ENGLAND AND WALES) 1967 PR. No. 11 (E & W)

In the Matter of the RESALE PRICES ACT 1964 and in the Matter of a Reference of BREWING ENZYMES AND ANTIOXIDANTS.

Notice is hereby given pursuant to Rule 8 of the Restrictive Practices Court (Resale Prices) Rules 1965 that on the 9th day of January 1967 there was issued out of the Restrictive Practices Court in England and Wales a Notice of Reference applying to the following classes of goods:

Brewing proteolytic enzymes; brewing antioxidants within headings 29.40 or 38.19 of the Convention on Nomenclature for the Classification of Goods in Customs Tariffs (Cmnd. 1070) commonly known as "the Brussels Nomenclature".

Unless the Court otherwise directs these proceedings will take place in England.

And notice is hereby further given that:

- (a) any supplier of goods of any of the classes to which the said Notice of Reference applies who supplies such goods under arrangements for maintaining minimum prices on resale but who has not duly given notice to the Registrar pursuant to section 6(2) of the said Act in respect of such goods
- (b) any retailer of goods of any of the classes to which the said Notice of Reference applies and
- (c) any trade association representing employees in the distributive trades

who wishes to be represented before the Court in the proceedings must notify the Registrar of Restrictive Trading Agreements at the address above in writing within 28 days hereof stating the nature of his interest and whether he supports or opposes the maintenance of minimum resale prices in respect of all or any of the goods to which the said Notice of Reference applies and giving the name of his Solicitor (if any) and an address in the United Kingdom at which documents may be served upon him.
