(c) Vehicles used for the purpose of delivering

or collecting postal packets.

(d) Vehicles used for the collection of household refuse etc. if they cannot be used for such purposes without waiting on the carriageway.

(e) Vehicles waiting while a gate etc., is being

opened or closed.

(f) Vehicles waiting when the person in control

(i) is required by law to stop

(ii) is obliged to do so in order to avoid an

accident

(iii) is prevented from proceeding by circum-stances outside his control and it is not reasonably practicable for him to drive or move the vehicle to a place not on any main carriageway.

(g) Public service vehicles used for providing transport in pursuance of arrangements made under the Education Acts.

The Order will also prohibit the waiting of vehicles on any verge or lay-by immediately adjacent to a main carriageway of the length of road specified for the purpose of selling goods from the vehicles unless the goods are immediately delivered at or taken into premises adjacent from which sale can be affected.
