

HERTFORDSHIRE COUNTY COUNCIL

The Hertfordshire County Council (Fore Street, Hertford) (One-Way) Order, 1967

The Hertfordshire County Council propose to make an Order under section 26 of the Road Traffic Act, 1960, the effect of which will be to impose one-way traffic in that part of Fore Street, Hertford:

(1) between its junction with Market Street and its junction with South Street, with traffic moving from east to west.

(2) between its junction with the eastern leg of Market Place and its junction with Parliament Square, with traffic moving from west to east.

An exemption will be provided in the proposed Order to enable Stage and Express carriages to use that part of Fore Street described in (2) above in both directions.

HERTFORDSHIRE COUNTY COUNCIL

The Hertfordshire County Council (Maidenhead Street, Hertford) (Prohibition of Through Traffic) (Experimental) Order, 1967.

The Hertfordshire County Council propose to make an Order under section 28 of the Road Traffic Act, 1962, the effect of which will be to prohibit through traffic in Maidenhead Street, Hertford, between its junction with The Wash and its junction with Bull Plain.

Exemptions will be provided in the Order to allow access to property in Maidenhead Street, which will remain one-way.

KIRKBY URBAN DISTRICT COUNCIL

The Urban District Council of Kirkby (Moorgate Road, Bewley Drive and Britonside Avenue) (Prohibition of Waiting) Order, 1967.

Notice is hereby given that the Urban District Council of Kirkby propose to make an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which will be to prohibit the waiting of vehicles at all times in the following lengths of road:

- (a) Moorgate Road: both carriageways;
- (b) Bewley Drive: both sides, from its junction with Moorgate Road to the junction of Kilsail Road;
- (c) Britonside Avenue: both sides, from its junction with Moorgate Road to the junction of Lindby Road.

Exceptions will be provided in the Order permitting vehicles to wait: to enable persons to board or alight; to enable goods to be loaded or unloaded; to enable works to be carried out in the lengths of road concerned; in connection with any funeral, building operation or demolition; to enable fire engines, ambulances and other local or public authority vehicles to be used in pursuance of statutory powers and duties; or in cases where the driver is prevented from proceeding by circumstances beyond his control.

LANCASHIRE COUNTY COUNCIL

The Lancashire County Council (Halifax Road A.58, Wardle) (Prohibition of Waiting) Order, 1967

Notice is hereby given that the County Council propose to make an Order under sections 26 and 27 of the Road Traffic Act, 1960, subject to the consideration of any objections which may be received, the effect of which will be to prohibit waiting from 7 a.m. to 7 p.m. each day on both sides of Halifax Road, A.58, Wardle, from the Rochdale County Borough boundary to a point 50 yards east of its junction with Greenfield Lane.

The Order will contain exemptions to allow vehicles to wait for as long as may be necessary for them to be loaded or unloaded; for persons to board or alight; for their use in connection with building operations, road works and the maintenance of essential services.
