TOWN AND COUNTRY PLANNING ACT 1962

The Secretary of State hereby gives notice that he has made an Order under section 153 of the above Act entitled "The Stopping up of Highways (County of Glamorgan) (No. 2) Order 1967" authorising the stopping up of a length of road at Llanwonno, Glamorgan, and involving the provision of new roads.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 24th January 1967, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
