

Companies (1) to forward to the Registrar of Companies as required by Section 126 of the above-mentioned Act the Annual Return of the said Company for each of the years 1962 to 1965 (inclusive) (2) to send to the Registrar of Companies as required by Section 200 of the said Act (a) a return in the prescribed form containing particulars of the Directors and Secretary of the said Company and (b) a notification of any changes among the Directors of the said Company or in its Secretary or in their particulars and (3) to give to the Registrar of Companies as required by Section 107 of the said Act (a) a notice of the situation of the registered office of the said Company and (b) a notice of any change in the situation of such registered office (if such be the case)

The Court ordered that the name of the above-named F. & T. Clubb (Haulage) Limited be restored to the Register of Companies

And it is ordered that an Office copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said F. & T. Clubb (Haulage) Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this Order in his official name in the *London Gazette*.

And it is ordered that the Petitioners the said F. & T. Clubb (Haulage) Limited Thomas Alexander Hardy and Anthony Gerald Fell do pay to the Registrar of Companies his costs of the said Petition
