EXPLANATORY NOTE

(This Note is not part of the Order.)

The Southern Rhodesia (Prohibited Trade and Dealings) Order 1966 makes it an offence for certain persons to commit certain acts whether within the United Kingdom or Southern Rhodesia or elsewhere. This Order enlarges the category of such persons to include certain classes of citizens of the United Kingdom and Colonies. British subjects without citizenship and British protected persons who were not hitherto included. It also makes certain amendments to the Southern Rhodesia (Petroleum) Order 1965, to bring it into line with the Order of 1966 in this respect.
