

CHEADLE RURAL DISTRICT COUNCIL

*Highways Act, 1959**Cheadle Rural District Council (Consall Forge) Public Path Diversion Order, 1966*

Notice is hereby given that on the 30th day of January 1967, the Minister of Housing and Local Government confirmed, with modifications, the above Order.

Its effect is to divert the public right of way running in a north-easterly direction across the stream between the parishes of Consall and Kingsley from a point approximately 100 yards south of Dalesprink Cottage to the footbridge across the River Churnet, approximately 54 yards east of Dalesprink Cottage; to a line running along the southern bank of the stream for approximately 64 yards and then crossing the stream at a new footbridge to re-join the original route at the bridge across the River Churnet. The old path will be closed from the 28th February 1967.

A copy of the confirmed Order and the map contained in it has been deposited at, and may be inspected free of charge at, the Council Offices, Leek Road, Cheadle, between 9 a.m. and 5 p.m. on weekdays.

The Order becomes operative as from the 10th day of February 1967, but if any person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.

COUNTY BOROUGH OF SWANSEA

*Highways Act 1959**Diversion of Highways*

Notice is hereby given that the Council of the County Borough of Swansea, the Highway Authority, intend to apply pursuant to the provisions of section 108 of the Highways Act 1959 to the Magistrates' Court sitting at Alexandra Road, Swansea aforesaid, on Thursday the 16th day of March 1967, at the hour of 10.30 in the forenoon, for an Order that for the purposes of all traffic, a certain unmade footpath starting between numbers 70 and 72 Frederick Place and continuing due south along Blaen Crymlyn Farm Road for a distance of approximately 65 yards turning due west at the rear of number 70 Frederick Place for a distance of approximately 25 yards and then running in a south-westerly direction alongside boundaries of properties on both sides of Brynteg for a distance of approximately 155 yards to Lon Brynawel, be diverted from the old right of way at approximately 65 yards south of Frederick Place, to run in a southerly direction for a distance of approximately 35 yards to the new estate road, and thereafter along the new estate road in a southerly direction to the junction of the old right of way at Lon Brynawel, so as to make it more commodious to the public.

The effect of the Order applied for is shown in the plan which may be inspected free of charge at the

offices of the Council at the Guildhall, Swansea, during normal office hours on weekdays (except Saturdays).

CHANCTONBURY RURAL DISTRICT COUNCIL

*HIGHWAYS ACT, 1959**Chanctonbury (Henfield—Footpaths Nos. 2582 and 2582/1, Canons, Hollands Lane) Public Path Diversion Order, 1967.*

Notice is hereby given that the above Order made on the 7th day of February 1967, is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to divert the public rights of way described in A and C of the Schedule below to the routes described in B and D of the Schedule.

A copy of the Order and the map contained in it has been deposited at the Offices of the Rural District Council of Chanctonbury, Church Street, Storrington, and may be inspected free of charge during normal office hours.

Any objection concerning the Order may be sent in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, before the 15th day of March 1967, and should state the grounds on which it is made.

SCHEDULE

A—Description of site of existing path

Footpath No. 2582/1 which begins at a point marked D on the map referred to above, crosses the curtilage of "Canons", Hollands Lane, Henfield and runs beyond, extending for an overall distance of 590 feet in a north-westerly, north-easterly and then westerly direction to a point marked B on the map.

B—Description of site of new path

Starting at a stile to be erected at a point marked E on the map, on the north side of Hollands Lane 110 feet west of the aforementioned point D and extending north-westward for 545 feet to a point marked C on the map where a stile is to be erected, then eastward for 190 feet to the aforementioned point B.

C—Description of site of existing path

Part of Footpath No. 2582 which part starts at the aforementioned point B and extends for 240 feet north-westward to a point marked A on the map.

D—Description of site of new path

Starting at the aforementioned point A and extending south-eastward for 120 feet to the aforementioned point C. The new route then extends between points B and C of the new line of Path No. 2582/1, also created by this Order.
