#### BOLDON URBAN DISTRICT COUNCIL

*The Boldon Urban District No. 3 Smoke Control Order, 1967*

Notice is hereby given that the Boldon Urban District Council in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 22nd day of February 1967, made an Order entitled the Boldon Urban District No. 3 Smoke Control Order, 1967, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by virtue of section 11 (4) of the Act, if on any day after the Order has come into operation smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before the 1st day of December 1967, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map referred to therein may be inspected free of charge at the offices of the Boldon Urban District Council at all reasonable times during the period of six weeks from the 1st day of March 1967.

Within the said period any person who will be affected by the Order may by notice in writing to The Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

#### SCHEDULE

The boundary of the area can be described by a line commencing at a point in the centre of the A.19 South Shields/Sunderland road adjacent to the curtilage of the property known as Cleadon Meadows Filling Station and thence in a northerly direction along the centre of the said A.19 for a distance of 140 yards. Thence in a westerly direction for a distance of 340 yards, and thence in a southerly direction for a distance of 110 yards, and thence in an easterly direction for 207 yards, and thence in a southerly direction for a distance of 122 yards to the centre of the road known as Boldon Lane, and thence in an easterly direction along the said Boldon Lane, for a distance of 23 yards, and thence in a northerly direction for a distance of 57 yards, thence in an easterly direction for a distance of 23 yards, and thence in a northerly direction for a distance of 80 yards, and thence in an easterly direction for a distance of 63 yards to the point of commencement.
