The QUEEN has been graciously pleased to give orders for the name shown below as having received an expression of Commendation for Brave Conduct:

23685640 Corporal (Acting-Sergeant) James Slaven DEVINE, Royal Corps of Transport.

On 9th November 1966, Corporal Devine was in charge of a working party aboard a vessel unloading stores at Salalah, a small port East of Aden. The craft was struck by a cyclone, and believing it to be in danger of sinking, ordered the soldiers to swim ashore. One of them, who was in fear of his life and unable to swim, refused to comply with the order.

Corporal Devine reasoned with him and set an example, by jumping into the sea. He grabbed a nearby empty oil drum and persuaded the soldier to jump. This he did but on striking the water, panicked and struggled. Without concern for his own safety, Corporal Devine overpowered the panic-stricken soldier and supported him until he was picked up.

The example and action of Corporal Devine undoubtedly saved the soldier's life and did much to instil discipline and order among the soldiers and civilian crew on board the vessel.
