The QUEEN has been graciously pleased to give orders for the name shown below as having received an expression of Commendation for Brave Conduct:

Captain Colin LINDSAY (440077), The Cameronians (Scottish Rifles).

On the evening of 18th January 1967, Captain Lindsay was on security patrol in Aden. His suspicions were aroused by a local national whom he noticed lurking in an ill lit side street. On dismounting from his vehicle, Captain Lindsay approached the man who ran off. In the middle of the chase, when called upon to halt, the man threw a grenade at Captain Lindsay, which exploded narrowly missing him. Oblivious to the danger Captain Lindsay continued the pursuit, but as there was likelihood of the terrorist eluding him he drew his pistol and shot him.

Captain Lindsay's skill, spirited action and his bravery under direct terrorist attack were conspicuous and in the best traditions of the Service.
