To the **QUEEN** of Great Britain.

The humble Address of her faithful and obedient Subjects, the Mayor, Aldermen, Capital Burgeses, and other the Inhabitants of Your Majesty's loyal and ancient Borough of **Truroe**, within the County of **Cornwall**; presented to her Majesty by the Right Honourable **Peregrine Bertie**, and **Thury Vincent**, Esq; their Representatives in Parliament.

May it please Your Majesty,

WHEN we had seen the Glory of Your Majesty's Reign, and enjoy'd the common Happiness of it, and had frequent Occasions to congratulate Your eminent and repeated Victories in Foreign Countries, and Your adding Security to the Protestant Succession, and Your great Work of uniting two King-doms, and acting with Advice of Your two Houses, and continuing Your Royal Favour to those great and wise Ministers, who have faithfully serv'd Your Majesty and their Countries we thought nothing could break in to disturb, or so much as to alarm the Peace and Prosperity of Great Britain, under Your Majesty's auspicious Life and Reign. We were the more surpris'd to hear of a **Life strange Attempt** made by the French King, to invade (as he thought) a Part of Your Majesty's Dominions, and to try to set up an unknown Pretender, bred under him in the Principles of idolatry and Tyranny. We could not fear that such a desperate Design should have any probable Success, while Your Majesty reign'd, under the Providence of God, in the Hearts of Your People: We look'd upon it rather as the last Effect of a perfidious Enemy in a sinking Cause.

We bless God for Your Majesty's Wisdom in fitting out a Fleet with so much Expedition, as to prevent their first Enterprise; and in taking such Measures as may effectually hinder their resuming any such vain Imagination: And we beg Leave at this Juncture to declare and protest, that we will faithfully adhere to Your Majesty's Person and present Administration, to Your Majesty's only right and lawful Title, to the only legal Protestant Succession, to the inviolable Union of North and South Britain, to the Reform'd Religion by Law establish'd, and to our daily Prayer, for Your Majesty's Victory over all Your Enemies, the sure Way to bring Peace and a Balance to all Europe.

May it please your Majesty,

FROM a just Abhorrence of the pernicious Designs of the French King to invade your Majesty's Realms, and to set a Popish Pretender upon the Throne, to the utter Destruction of our happy Establishment in Church and State:

We humbly beg Leave to assure your Majesty, That we will both now, and at all times, and on all Occasions hereafter, to the utmost of our Power, assist and stand by your Majesty, in the Defence of your sacred Person, the Church of **England**, and the Protestant Succession, as by Law establish'd, against all Attempts whatsoever.

Which Declaration (as a Record to Posterity) is not only attested in the usual Forms of our Corporation; but we are ready upon the first Occasion to seal it with our Blood.

Brussels, April 19. N. S. Letters from Paris of the 16th say, that on the 12th Instant the new Colours and Standards of the Household were brought by two Companies of the Mousquetaires to the Church of our Lady; and that the Cardinal of Noailles perform'd the Ceremony of giving them the Blessing. The Troops of the Household are to march to morrow for Flanders; but the Duke of Vendome does not set out 'till the latter end of this Month. The pretended Prince of Wales is not yet return'd to St. Germain. It is said he is to serve the ensuing Campaign. All the Vessels which were employ'd in his late Expedition are return'd to Dunkirk, except the Salisbury, and three other Ships, which had on Board 16 Companies of Regular Troops. The last Advices to Paris from Madrid reported, That the Duke of Anjou continu'd his daily Conferences with the Duke of Orleans and the General Officers, for raising Funds, and making Dispositions for carrying on the Service of the next Campaign. Monsieur Chamillard, who has been some Days at Mons, was Yesterday for the Space of three Hours in private Conference with the Elector of Bavaria, and 'tis said he will go from this Place on the 21st to view the Garrisons of Charleroy and Namur.

Hague, April 20. N. S. This Evening Prince Eugene went in a Yatch of the States to Utrecht, where he designs to take Post, and go to Vienna by the way of Dusseldorp. Prince Eugene having earnestly entreated his Grace the Duke of Marlborough to meet him at Hanover, and the States General having represented to Her Majesty of Great Britain, how uncertain the Winds might make his timely return from England, now the season is so far advanc'd, the Duke will set out on Monday next for the Court of Branfwick. The States have made the Earl of Albemarle General of the Works, and Monsieur Lagel General of the Foot.
