Whereas the Minister of Housing and Local Government, after giving to the Incumbent and Churchwardens of the Parish of Hope, near Sheffield in the County of Derby, ten days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to Her Majesty in Council that, for the protection of the Public Health, burials should be discontinued forthwith and entirely in St. Peter's churchyard in the said Parish:
