

## WATER RESOURCES ACT, 1963

NOTICE OF APPLICATION TO  
ABSTRACT WATER

Notice is hereby given that an application is being made to the Hampshire River Authority by Southern Gas Board of 164 Above Bar, Southampton, for a licence to abstract the following quantities of water from the River Itchen at the following point of abstraction: 2,166 gallons per day at O.S. National Grid Map Co-ordinate SU 466175 at Eastleigh in the County of Hampshire.

The water is required for the hydraulic testing of a steel pipeline. The total abstraction will be 6,500 gallons during the period August/December 1967 and two-thirds of the amount abstracted will be discharged at the point of abstraction after completion of testing.

- (a) Not more than 20,000 gallons in any one hour;
- (b) Not more than 400,000 gallons in any one day of twenty-four hours reckoned from midnight to midnight; and

for is the continuance of existing right on a permanent basis.
