*Military Cross*

Major Alan Middleton JENKINS (369289), 7th Duke of Edinburgh's Own Gurkha Rifles.

During one fortnight of this operational period Major Jenkins commanded a company in very high, cliff-strewn mountains covered in dense primary jungle, and in a period of extremely heavy rains which caused the streams and rivers to flood in their sheer gorges and ravines.

The company were following the tracks of an enemy incursion group led by a notorious leader. In this appallingly savage terrain and weather, movement at any pace was hazardous, but because the company had to move as fast as possible in order to catch up with the enemy, movement was even more dangerous and on many occasions men slipped and were nearly killed by the flooded rivers or stark, treacherous cliffs.

Under these conditions it was the grim determination, the gallant personal leadership and the great perseverance and initiative displayed by Major Jenkins that inspired his men to tremendous efforts, resulting in the elimination of all of the enemy group that they were following. The total number of enemy accounted for was twenty-four, including the leader.

Major Jenkins knowing that the capture of the enemy leader would provide extremely valuable information, was determined to take him alive. This he did at considerable risk to himself and his men. The subsequent interrogations proved the very great value of the captured enemy leader.

On this occasion, as on many occasions in the past two years when on operations in Borneo, Major Jenkins showed gallantry and leadership of a very high order. This officer has always been an inspiration to everyone.

*Military Cross*

Lieutenant (Q.G.O.) BHAGISOR LIMBU (477211), 10th Princess Mary's Own Gurkha Rifles.

This officer has commanded his platoon in D Company on active operations along the Sarawak border. His platoon has killed a total of 27 enemy at a loss to themselves of 2 killed and Lieutenant Bhagisor Limbu has personally killed seven enemy. His greatest contribution to his platoon's success has been the aggressive and courageous leadership he has shown at all times. By his personal example and conduct he has instilled into every man under his

command the determination to seek out, bring to battle and destroy the enemy wherever and whenever he can be found.

In three separate attack operations he has shown personal gallantry of the highest order and his actions have contributed in large measure to the notable success achieved on each occasion.

In the Biawak battle he led a small group from his platoon into the very centre of the enemy position where they were able to annihilate with grenades and automatic fire an enemy strong point. Showing great courage this officer finally moved forward on his own to ensure that all the enemy had been killed and was able to claim six dead. His apparent indifference to the inherent dangers of his action gained the admiration of all who saw him. Later in an operation in the Serikin area, his platoon had the mission of attacking an entrenched enemy position while other platoons cordoned the escape routes. Despite two of his men being killed at the outset of the attack he led the remainder through the outer and inner defences and finally occupied the entire enemy position, counting twenty enemy dead before he withdrew. In both these major battles Lieutenant Bhagisor Limbu showed a complete disregard both for his own safety and of the intense enemy fire, inspiring his men by his example and ensuring success by his intrepid leadership.

In the action at Gumbang his professional skill and intimate knowledge of the enemy, gained by close reconnaissance of the enemy position, combined with his aggressive tactics resulted in another decisive defeat for the enemy and their complete withdrawal from the area.

Over a very long period he has proved beyond doubt that his justly earned and incomparable reputation for personal bravery and aggressive, determined leadership have been the decisive factors in his platoon's success.

*Bar to Military Medal*

21148605 Lance Corporal NAINABAHADUR RAI, M.M., 7th Duke of Edinburgh's Own Gurkha Rifles.

On 24th June during a search operation in thick secondary jungle Lance Corporal Nainabahadur with 3 men formed a small group the immediate task of which was to clear a particularly thickly overgrown gully. As Nainabahadur's group approached the gully 2 enemy cautiously emerged and on seeing the group darted back into the undergrowth.

Lance Corporal Nainabahadur shouted out that he had made contact and ordering two men of his group to cover him, he took the third rifleman and plunged in after the enemy. The undergrowth was so thick that visibility was reduced to a couple of yards and both soldiers had to crawl and push their way through the tangled brush. After about 15 yards one enemy was seen at about 3 yards distance burrowed into thick fern and scrub and Lance Corporal Nainabahadur called on him to surrender. The enemy opened fire at point blank range but, because of his awkward position missed Lance Corporal Nainabahadur. He and the rifleman with him opened fire and killed the enemy.

Knowing that another enemy was in the immediate area Lance Corporal Nainabahadur called up the other 2 riflemen of his group and organised a search that resulted in the second enemy being captured some 30 minutes later.

Throughout the action Lance Corporal Nainabahadur showed great coolness, initiative and leadership under fire far in excess of that expected of a junior Lance Corporal. His behaviour was an inspiration and example to the rest of his platoon.

#### *Military Cross*

Lieutenant (temporary Captain) Rodney Gerard CURTIS (57068) Royal Australian Infantry Corps.

Lieutenant R. G. Curtis was commanding a party of nine men sent to block the withdrawal of an enemy party being followed up after a previous contact. By sound judgment he selected an ambush position astride one of many possible enemy escape routes.

At about 1740 hours the enemy appeared unexpectedly in the rear of the ambush position. Only Lieutenant Curtis and one other soldier were able to bring fire to bear on the enemy. He held his fire until the enemy were within ten paces. Realising that the enemy could easily escape if they spotted his ambush, which was not sited for an approach in that direction, he opened fire and killed one of the leading enemy. The remaining enemy adopted a good position under cover on a narrow, jungle covered ridge line. Although pinned down by enemy fire at close range, Lieutenant Curtis directed operations, and issued orders for the six men able to move to assault from the right. He covered the movement of this party by fire. After one soldier was wounded he called off the assault just as reinforcements arrived. These consisted of one section of his own platoon and one section of another platoon under Second Lieutenant M. Chambers. He took control of this mixed reinforcement party, and with a well thought out plan he confidently directed them to the final destruction of a brave and determined enemy party. Four out of the five enemy, including one officer, were killed. Documents taken from the enemy dead were of the greatest national importance. The success of this contact had far reaching effects on subsequent operations.

Lieutenant Curtis displayed the highest qualities of cool leadership, bravery, judgment and determination in a difficult and dangerous situation.

#### *Military Medal*

4410450 Private Richard Roy ANDERSON Royal Australian Infantry Corps.

Private Anderson was a member of an ambush party of ten men sited to cut off a party of enemy which was being followed up after an earlier contact.

At about 1740 hours the enemy appeared unexpectedly at the rear of the ambush, Private Anderson was one of two soldiers able to bring fire to bear. His fire killed one of the leading enemy. The remaining enemy took cover fifteen paces from Private Anderson. The officer commanding the ambush and the non commissioned officer present were pinned down by enemy fire and were unable to move to a position to control an assault. Private Anderson was in the best position to control an assault onto the enemy position. He interpreted and passed on his platoon commander's orders. When the six soldiers able to move arrived in a position to assault from the right flank, he calmly and confidently assumed control. He organised them into

extended line and covered their movement by fire and by throwing grenades.

He realised that the machine gun was not in the best position so he crawled forward under fire, took over the machine gun and moved it to a better position. His actions and example contributed greatly to the success of the operation in which four of the five enemy were killed.

Circumstances placed him in a position of unexpected responsibility and danger from a very determined and brave enemy. He was under enemy fire at close range for over 30 minutes. During this period, his leadership, actions and bravery were in the highest traditions of the Service, and were an inspiration to all.

#### *Air Force Cross*

Flying Officer Brian William SKILLICORN (685675),  
 Royal Air Force.

On 10th August 1966, Flying Officer Skillicorn was captain of a Whirlwind helicopter on an operational flight in Sarawak. As he reached a point about 250 yards on final approach to a hilltop landing site in trees on top of a hill at a height of 1,400 feet above the nearby plain, there was a loud bang from the engine followed by complete loss of power. He quickly turned the helicopter away from the hill, recovered the rapidly decaying rotor R.P.M. and established an autorotative descent towards the plain, which was covered with a mixture of primary and secondary jungle relieved by only a few very small patches of swamp and primitive cultivation. Flying Officer Skillicorn selected a clearing within his limited range and began his circuit. He then discovered that the clearing was obstructed by fallen trees and at almost the last moment had to change his approach to reach an even smaller clearing, about 75 yards long and 25 yards wide separated from his first choice by a screen of trees and limited further

by a stream which cut it in two. Despite this setback and the fact that the whole incident, from engine failure to landing, occupied little more than one minute, Flying Officer Skillicorn transmitted clear correct distress calls and adjusted his approach to reach the second clearing. He cleared the screen of trees, but to do so had to manoeuvre the helicopter between two taller trees so close that the tips of the main rotor blades were slightly damaged. On landing, it was found that the ground was soft and the front wheels dug in, pitching the helicopter forward and breaking off the tailboom. Neither Flying Officer Skillicorn nor his co-pilot were injured. Flying Officer Skillicorn is 23 years old and is now in the second year of his first flying tour, in which he served initially with No. 225 Squadron, when he was mentioned in despatches. Since November 1965, he has served with No. 103 Squadron. Previous to the incident now reported, he once successfully landed a helicopter in a jungle clearing after a tail rotor failure and on another occasion landed safely on a beach after an engine failure. A pilot without Flying Officer Skillicorn's qualities of determination and skill would, in the circumstances he encountered on 10th August 1966, have had to accept a crash landing, with severe injuries or loss of life for his crew being the normally inevitable result, but, by his cool, courageous and skilful handling of the situation, Flying Officer Skillicorn ensured the safety of his crew and, but for the treacherous nature of the ground would have saved his aircraft even from the damage it sustained. In a Force whose bravery and professional expertise have aroused general admiration, his own record has been second to none. His fine example has been an inspiration and an encouragement to his fellow pilots, all too well aware of the hazards of flying single-engined aircraft over this inhospitable terrain.
