The QUEEN has been graciously pleased to approve the following awards for gallant and distinguished services in operations in the South Arabian Federation:

*Military Cross*

Captain (Local Major) Donald Jeffrey BREWSTER, Royal Marines.

From 14th September-10th November 1966, Major Brewster commanded X Company 45 Commando Royal Marines in a series of operations against the dissident tribesmen in Qutaibi Province of the South Arabian Federation.

On 13th October 1966 X Company Group, consisting of a mixed force of commandos and parachute troops with an 81mm mortar and a 105 mm gun, was operating in the Wadi Taym, an area notorious for dissident activity.

On the night of 14th October his Company was attacked by very heavy and extremely accurate blindicide and mortar fire from the south and by automatic weapons and rifle fire from the west, several sangars received direct hits from blindicides.

Regardless of his own personal safety and despite enemy mortar fire falling within a few yards of his command post, Major Brewster controlled the fire of his 81 mm mortar and 105 mm gun on to the enemy positions with great coolness, with a result that one dissident was killed and at least five others wounded. The dead man was a well known experienced leader of the principal dissident organisation in the area.

On 3rd November, again in the Wadi Taym area, but this time as part of a larger operation, Major Brewster commanded his company group as a decoy force, which included two 81mm mortars, a 105mm gun and a Radar team. Information was received that the dissidents were planning three ambush positions for the night 4th/5th November. Showing commendable foresight, Major Brewster deduced that the positions concerned would more probably be used as fire positions for an attack against his main position. He ordered his mortars to be silently registered and laid on these targets.

At 0030 hours on 5th November, the Company were subjected to a heavy blindicide attack for about ten minutes, coupled with very accurate direct and plunging rifle fire which swept in over the tops of the sangars.

With great coolness and presence of mind, Major Brewster controlled the return of fire from his gun and mortars by a combination of radar and visual means. That this was immediately effective was due to the forethought and the high standard of professional skill he displayed throughout the operation and in particular during the engagement itself. At least one dissident was killed and two others wounded. The casualties inflicted in the two operations had a salutary effect on the dissidents in the area, and did much to strengthen the confidence of the local population.

Major Brewster displayed professional competence of the very highest order during the planning and execution of these operations, during which only one of his own men received minor wounds. Throughout, his cheerful disregard for his own personal safety was an inspiration and outstanding example to his men, and in the very highest traditions of the Service.

*Military Medal*

R.M. 17064 Sergeant Peter LITTLEWOOD, Royal Marines.

During October and November 1966, Corporal (now Sergeant) Littlewood was the 81mm Mortar Section N.C.O. of X Company, 45 Commando, Royal Marines, and was operating with the company in the Wadi Taym area of Qutaibi Province in the South Arabian Federation.

On 14th October, X Company position was heavily attacked by dissidents from two directions at once—with mortars and blindicides from the south, and automatic and rifle fire from the west. The mortar pit sangar suffered a direct hit from a blindicide and enemy mortar shells were landing close by. Under very heavy fire and with complete disregard for his own safety, Corporal Littlewood directed and inspired his crew to switch the mortar through an arc of 180 degrees so as to engage the enemy. The commendable speed at which he completed this hazardous task and the accuracy of the fire he brought down were instrumental in the enemy sustaining severe casualties.

On the night of 4th/5th November, again in the area of the Wadi Taym, X Company which was acting as a decoy force was heavily attacked with blindicide, automatic and rifle fire. The small arms fire was intense and included direct and plunging fire sweeping into the mortar pits.

The enemy dispositions were such that it became necessary for each mortar to engage a separate target. Although he was receiving fire control orders from two sources, and still under heavy fire, which

was falling around his position, with great coolness Corporal Littlewood kept the mortars firing without a stop. The speed with which he worked out corrections on the plot enabled fire to be effective throughout the engagement and again resulted in severe enemy losses.

In both operations, Corporal Littlewood acted with an extremely high degree of professional skill, initiative and coolness under fire. His outstanding leadership provided a magnificent example not only to his own mortarmen, but to the company group as a whole.

#### *Military Medal*

R.M. 18302 Corporal Patrick Anthony McGUIGAN, Royal Marines.

On the night of 4th/5th November 1966, Corporal McGuigan was a mobile fire controller for the 81mm mortars of X Company Group which was part of a force operating in the Wadi Taym area of Qutaibi Province in the South Arabian Federation. The company group was acting as a decoy force, and Corporal McGuigan had been allocated to the most isolated of the troop positions which lay astride the probable approach route for a dissident attack.

At 0030 hours the whole company, and in particular the troop to which Corporal McGuigan was attached, suffered a heavy and accurate attack with blindicide, automatic weapons and rifle fire. Enemy small arms subjected his troop to both direct and plunging fire, which swept into the forward sangar positions. The suddenness, speed and intensity of the attack called for vigorous, determined and controlled action. With great coolness, presence of mind and a complete disregard for his own safety in such an exposed position Corporal McGuigan controlled the fire of his own mortars on to the enemy positions. At the same time, he took command of the riflemen in whose position he was located and brought effective fire from the 2 inch mortar and the machine guns to bear on to the dissidents. This he continued to do until the enemy withdrew having suffered heavy casualties.

There is no doubt that Corporal McGuigan by his prompt and gallant action played a vital rôle in the successful outcome of the engagement. Furthermore his coolness and calmness under fire were an inspiration and a magnificent example to the younger and less experienced marines under his command.

#### *Military Medal*

22706578 Sergeant Reginald Charles AUSTIN, Royal Regiment of Artillery.

On the 13th October 1966, Sergeant Austin was in charge of a 105mm gun crew which was attached to X Company, 45 Commando Royal Marines for an operation in the Wadi Taym area of Qutaibi Province of the South Arabian Federation.

X Company's position was on the very open and exposed rocky feature known as Table Top. Through his drive and leadership Sergeant Austin managed to get his gun sangar constructed in the few remaining hours before last light. This was a gruelling task in the heat and dust, but his zeal was rewarded for, when darkness fell, the position immediately came under small arms fire. As the enemy were below them, it was difficult for the gun detachment to engage them without striking the top of the sangar. Well aware of the danger and regardless of the enemy fire, Sergeant Austin calmly controlled accurate fire on to the enemy, the rounds passing only a few millimetres over the sangar lip.

At 23.15 hours the following night, the company was heavily attacked from two directions at once, with mortars and blindicides from the south and automatic weapons and rifle fire from the west. Although Sergeant Austin's sangar received a direct hit from a blindicide, the building was so sound that there were no casualties. Led by him with complete disregard for his own safety, the crew moved the gun through an arc of 180 degrees under heavy fire, removed the armoured shield and stanchions which were obscuring the night aiming lamps, and engaged the dissident mortars at a range of 500 metres. As a result of this action the enemy lost a most important leader and at least five others were wounded before they withdrew.

Throughout the operation Sergeant Austin's energy, sense of duty and cheerful efficiency were an outstanding example to all. His foresight and professional ability certainly prevented casualties and his courage and determination under fire greatly influenced the successful outcome of the engagement.
