(d) Where the rating had 22 or more years' reck-onable service and would have been eligible for onable service and would have been engage for a terminal grant in addition to any other non-effective benefits, a sum equal to 90 per cent. of the amount of the terminal grant for which the rating would have been eligible if he had been discharged in the normal way on the day he died may be added to any gratuity payable under Sub-Clause (c) above.

5. Where death is attributable to service. Where an attributable gratuity is awarded a modified service gratuity may be granted in addition, assessed as at Clause 4 but reduced by 25 per cent.

6. The following dependent relatives only will be eligible for consideration for the award of a service gratuity:

(a) Widow.(b) Children (including step children and illegitimate children) under the age of 14 years.
