(b) In any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave. the grave.

2. This Order may be cited as the Burial Grounds (Aylesford Churchyard, Aylesford, Kent) Order 1967.
