The QUEEN has been graciously pleased, on the advice of Her Majesty's Australian Ministers, to approve the undermentioned award in recognition of gallant conduct in Vietnam:

To be dated 14th September 1967

### *Distinguished Conduct Medal*

214091 Sergeant (Temporary Warrant Officer Class II) William Barry ROGERS, Royal Australian Infantry Corps.

Warrant Officer Class II William Barry ROGERS enlisted in the Australian Regular Army on the 6th June 1961 and was allotted to the Royal Australian Regiment. He volunteered for duty in Vietnam and joined the Australian Army Training Team on 3rd January 1967.

He was posted to the MIKE FORCE (Reaction Force) of 5th Special Forces Group (Airborne) where he was given command of a platoon of indigenous soldiers in 11 Company. On 19th February 1967 the company conducted a cordon and search of BAN CO Village in QUANG NGAI Province where W.O. II ROGERS and his platoon were ordered into the attack position, while the other two platoons cordoned the village. During the move into position five armed enemy moved towards the attacking platoon, were fired upon with no results and escaped into the village. The company was then ordered to attack the village quickly, and soon all platoons came under intense small arms fire from the North-west and North-east sections of the village. As the company moved to secure the high ground on the North-east of the village they came under more heavy fire and the troops halted and took cover. W.O. II ROGERS on the right flank saw the company halt and ordered his platoon to attack the North-west portion of the village; followed by only two members of his platoon he moved across 200 metres of open ground covered by enemy fire and assaulted the enemy position in the woods on the edge of the village. This aggressive move unnerved the enemy and they tried to escape, and W.O. II ROGERS personally killed three of them. Seeing two more enemy fleeing from the village he chased them and exchanged fire with them until they escaped into the jungle. The company was then able to move in and search the village. During the search a vast tunnel complex was found and the indigenous soldiers, fearing booby traps, would not search them. W.O. II ROGERS then unhesitatingly entered the tunnels, searched them and destroyed several hundred kilogrammes weight of rice and found several boxes of small arms ammunition.

By his daring actions W.O. II ROGERS broke the resistance of the enemy ambush in the village and, his personal bravery and leadership set a strong and enduring example to the inexperienced soldiers of his platoon when he searched the tunnels by himself. By these courageous actions he has brought great credit on himself, the Australian Regular Army and the United States Army Special Forces.
