PRICES AND INCOMES ACT 1966

REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

Proposals by the London Transport Board and British Railways Board for Fare Increases in the London Area.

As announced by the Prime Minister on 7th September 1967, the Government have decided that all future proposals for significant price increases by publicly-owned industries should be referred for examination by the National Board for Prices and

The London Transport Board and British Railways Board have consulted the Minister of Transport about fare increases for the London area for which they propose to apply to the Transport Tribunal. They have proposed these increases in the light of their financial duty to balance their accounts as soon as possible.

Accordingly, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Transport hereby refer the question of the general level of the proposed increases in fares for the London area to the National Board for Prices and Incomes for examination against the background of the Government's policies for nationalised industries.

## Proposed Increases by British Railways Board in certain Country-Wide Fares and Charges

As announced by the Prime Minister on 7th September 1967, the Government have decided that all future proposals for significant price increases by publicly-owned industries should be referred for examination by the National Board for Prices and

Incomes.

The British Railways Board have consulted the Minister of Transport about increases which they propose to make in certain country-wide fares and charges in view of the need to contain their revenue deficit, which amounted to £135 million in 1966, and of their financial duty to balance their accounts as soon as possible.

Accordingly, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Transport hereby refer the question of

the increases proposed by British Railways in certain country-wide fares and charges to the National Board for Prices and Incomes for examination against the background of the Government's policies for nationalised industries.

## The Bulk Supply Tariff of the Central Electricity Generating Board

As announced by the Prime Minister on 7th September 1967, the Government have decided that all future proposals for significant price increases by publicly-owned industries should be referred for examination by the National Board for Prices and

Incomes.

Accordingly, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Power hereby refer the question of the increase envisaged by the Central Electricity Generating Board in the bulk supply tariff from 1st April 1968, to the National Board for Prices and Incomes for examination against the background of the Government's policies for nationalised industries, including the financial target for the relevant period. 3rd October 1967.

#### Post Office Charges

The Post Office has under consideration changes in the charges both for postal services and for telecomthe charges both for postal services and for telecommunications services; both increases and decreases would be involved. It is proposed that there should be an important restructuring of the pattern of postal services, on the basis of replacing the present letter and printed paper services by a two-tier system providing for a first and second class letter service at differential tariffs. Some changes in the present basis of charging for telephone services are also in mind. In considering what will be needed the Post Office has had regard to the foreseen growth in business and in the size of the telephone system, the expected increases in productivity, the requirements of the increases in productivity, the requirements of the Post Office capital investment programme and its financial obligations. The new tariffs would take effect in the case of telecommunications in the summer of 1968 and in the case of postal services in the autumn

of 1968.

The Government think it appropriate that these proposed changes should be examined by the National proposed changes should be examined by the National Board for Prices and Incomes. Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Postmaster-General hereby refer the question of the proposed changes in Post Office charges to the National Board for Prices and Incomes for examination on the assumption that the financial objectives of the postal and telecommunications services and the general programme of development for the industry are as approved by the Government for the relevant period. 3rd October 1967. 3rd October 1967.
