CONFIRMATION OF PUBLIC PATH ORDER

Atcham Rural District Council (Public Path No. 2A and part of Public Bridleway No. 9) Parish of Upton Magna, Extinguishment Order, 1967.

Notice is hereby given that on the 26th day of September 1967, the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect is to extinguish the following public rights of way in the Parish of Upton Magna:

(i) footpath No. 2A from the point of its commencement off bridleway No. 9, approximately five yards north of the northern side of the Shrewsbury-Wellington main railway line, running in a north-westerly direction across O.S. Field Nos. 451, 452 and 383 (Shropshire Sheet No. XXXV.9—1902 Ed.) to the point of its termination on joining footpath No. 2 a total distance of approximately 712 yards, and

(ii) that part of bridleway No. 9 (O.S. No. 446) from its junction with bridleway No. 10, at a point approximately 85 yards south of the Upton Magna-Downton Road adjacent Church House Farm and running in generally south-westerly direction over the said Shrewsbury-Wellington main railway line and across field O.S. 458 to its termination on joining Bridleway No. 12 on the Parish boundary a total distance of approximately 900 yards.

A copy of the Confirmed Order and the map contained in it has been deposited at the Council Offices, Oakley Manor, Belle Vue Road, Shrewsbury, and may be inspected free of charge at that address between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays inclusive.

The Order becomes operative as from the 6th day of October 1967, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.
