HAMPSHIRE COUNTY COUNCIL

The Hampshire (Beaulieu) (Prohibition of Waiting) Order, 1967

Notice is hereby given that on the 26th September 1967, the Hampshire County Council made an Order under sections 26 and 27 of the Road Traffic Act, 1960 and which will come into operation on the 16th October 1967, the effect of which will be:

- (a) To revoke the Hampshire (Beaulieu) (Prohibition of Waiting) Order, 1963; and
- (b) To prohibit the waiting of vehicles between the hours of 10 a.m. and 6 p.m. daily from the 1st March to the 31st October in any year in the length of road specified in the Schedule to this Notice.
