

than that specified in the second column of the said Schedule.

- (ii) To prohibit waiting by vehicles
- at any time in any of the lengths of road specified in the Second Schedule hereto.
 - between the hours of 8 a.m. and 6 p.m. in any of the lengths of road specified in the Third Schedule hereto.
 - between the hours of 8 a.m. and 6 p.m. on any day other than a Sunday in any of the lengths of road specified in the Fourth Schedule hereto.
 - for a longer period than 30 minutes at any one time or more than once in any consecutive period of one hour or after it has been taken away after such period until the expiration of one hour from the time it was taken away between the hours of 8 a.m. and 6 p.m. on any day other than a Sunday in any of the lengths of road specified in the Fifth Schedule hereto.
- (iii) To prohibit the loading or unloading of goods (other than by Post Office vehicles) between the hours of 8 a.m. and 6 p.m. on any day other than a Sunday in any of the lengths of road specified in the Sixth Schedule hereto.
- (iv) To revoke the Order or part of Order specified in the first column of the Seventh Schedule hereto to the extent indicated in the second column of that Schedule.

Exceptions are provided in the Order to permit persons to board or alight from vehicles, to enable goods to be loaded on to or unloaded from vehicles (except as aforementioned) and to enable vehicles to be used in connection with building operations, civil engineering works, funerals and furniture removals.

FIRST SCHEDULE

15. Carters Lane.	Towards Hill Street.

SECOND SCHEDULE

- Towngate Street (both sides) from its northernmost junction with Hunger Hill roundabout to its northernmost junction with High Street.
- Towngate Street (both sides) from its southernmost junction with Hunger Hill roundabout to a point 45 feet in a southerly direction.
- Roads (both sides) surrounding the Hunger Hill roundabout.
- High Street (northern side) from its northernmost junction with Towngate Street to the western boundary of the Dolphin Hotel.
- High Street (northern side) from the eastern boundary of the Dolphin Hotel to the eastern boundary of the Port Mahon Castle Hotel.
- High Street (southern side) from a point opposite its northernmost junction with Towngate Street to a point opposite the eastern boundary of the Port Mahon Castle Hotel.
- High Street (south-eastern side), from its junction with The Quay to a point opposite the northern boundary of 60 High Street.
- High Street (north-western side) from the northern boundary of 60 High Street to the northern boundary of 48 High Street.
- High Street (both sides) from the southern boundary of 136 High Street to the northern boundary of 128-130 High Street.
- Old Orchard (both sides).
- New Orchard (both sides) from its junction with High Street to a point 100 feet in a north-westerly direction.
- Lagland Street (both sides).
- South Road (both sides) from its junction with High Street to a point 100 feet south of its junction with Lagland Street.
- Green Road (both sides) from its junction with South Road to a point at the southern boundary of 99 Green Road.
- The Quay (northern side), from its junction with West Quay Road to the eastern boundary of Burden's premises.
- The Quay (southern side), from its junction with West Quay Road to a point opposite the eastern boundary of Thames Street with The Quay.
- West Quay Road (both sides) from its junction with Hunger Hill roundabout to a point 74 yards east of the junction with West Quay Road and West Butts Street.
- Nile Row (both sides) from its junction with Hunger Hill roundabout to a point 45 feet in a north-easterly direction.
- North Street (both sides), from its junction with Towngate Street to a point 45 feet in a south-easterly direction.
- Market Street (both sides) from its junction with Hunger Hill roundabout to a point 45 feet in a south-westerly direction.
- Castle Street (both sides) from its junction with High Street to a point 45 feet in a south-easterly direction.

THIRD SCHEDULE

High Street (northern side) for a length co-extensive with the frontage of the Dolphin Hotel.

FOURTH SCHEDULE

- High Street (north-western side), from the north-eastern boundary of the Port Mahon Castle Hotel to its junction with Wimborne Road.
- High Street (south-eastern side) from a point opposite the north-eastern boundary of the Port Mahon Castle Hotel to its junction with Parkstone Road.
- High Street (both sides), from its northernmost junction with Towngate Street to the southern boundary of 136 High Street except for that length on the north-western side from the southern boundary of 136 High Street to the southern boundary of 144-146 High Street.
- High Street (both sides), from the northern boundary of 60 High Street to the northern boundary of 128-130 High Street, except for that length of the road (north-western side) from the northern boundary of 60 High Street to the northern boundary of 98 High Street.
- Serpentine Road (both sides) from its junction with Towngate Street to a point 205 feet in a northerly direction.
- North Street (both sides), from a point 45 feet south-east of its junction with Towngate Street, to its junction with High Street.
