Costs and Revenue of National Daily Newspapers

On 25th July 1967, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, the First Secretary of State and the President of the Board of Trade referred the question of Costs and Revenue of National Daily Newspapers to the National Board for Prices and Incomes for examination.

The Board has now made its report and in accordance with section 5 (1) of the Prices and Incomes Act 1966 the Secretary of State for Economic Affairs and the President of the Board of Trade hereby give notice that the report was first published as Command Paper Number 3435 on 19th October 1967.

The Trunk Road (Trawsfynydd) (Prohibition of Waiting) (Revocation) Order 1967

Notice is hereby given that the Secretary of State has made an Order under section 28 of the Road Traffic Act 1960, to revoke the Trunk Road (Trawsfynydd) (Prohibition of Waiting) Order 1960, the effect of which is to remove the waiting restrictions in that length of the Fishguard—Aberystwyth—Dolgelly—Caernarvon—Bangor (Menai Suspension Bridge) Trunk Road (A.487) at Trawsfynydd in the county of Merioneth, which lies between a point 78 yards north of its junction with the access road to the Nuclear Power Station and a point 78 yards south of that junction.
