

TOWN AND COUNTRY PLANNING ACT 1962

Austerlands, Yorks.

The Minister of Transport hereby gives notice that she had made an Order under section 153 of the above Act entitled "The Diversion of Highways (County of York, West Riding) (No. 12) Order 1967" authorising the diversion of a length of footpath No. 173 off Thorpe Lane, Austerlands, Yorks.

ROAD TRAFFIC REGULATION ACT 1967

*The Trunk Road (Northway, Maghull)
(Prohibition of Cycling in Subway) Order 1967*

The Minister of Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967 the effect of which will be to prohibit any person from riding any pedal bicycle or tricycle, other than a child's tricycle, in the length of subway specified in the Schedule hereto.
