The London—Holyhead Trunk Road (Bron Ryffydd, Betws-y-Coed Diversion) Order 196 , and

The London—Holyhead Trunk Road (Bron Ryffydd, Betws-y-Coed Diversion Side Roads) Order 196

The Secretary of State hereby gives notice that he proposes to make the following Orders:—

1. an Order under section 7 of the above Act providing:

(a) that the roads which he proposes to construct at Bron Ryffydd, Betws-y-Coed, in the County of Denbigh, shall become trunk roads as from the date when the Order comes into operation, and
