Notice is hereby given that the West Sussex County Council in pursuance of sections 1 and 2 of the Road Traffic Regulation Act, 1967, propose to make an Order the effect of which will be:
(1) To revoke "The Administrative County of West Sussex (Southwick Urban District) (Traffic Regulation) Order, 1957 ".
(2) To prohibit the waiting by vehicles
(a) at all times in the length of road specified in the First Schedule hereto ;
(b) for a longer period than 60 minutes in any two hours between the hours of 9 a.m. and 6 p.m. in the length of road specified in the Second Schedule hereto;
(c) between the hours of 9 a.m. and 6 p.m. in the length of road specified in the Third Schedule hereto;
(d) between the hours of 8 a.m. and 8 p.m. in the lengths of road specified in the Fourth Schedule hereto.
(3) To prohibit the driving of any vehicle on the length of road specified in the first column of the Fifth Schedule hereto, otherwise than in the direction specified opposite to such length in the second column of the said Schedule.
Exceptions will be provided in the Order to enable vehicles to stop and pick up and set down passengers, goods or merchandise; to wait when engaged in building operations, or the repairs of the roads, or the services therein, or to take in petrol, oil, water or air from a garage, and in connection with funerals.

## First Schedule

(waiting prohibited at all times)
In the Urban District of Shoreham-by-Sea
Brighton Road: north side-from the junction with Kingston Lane, westwards for a distance of 30 yards. Brighton Road: south side-from the junction with Kingston Lane, westwards for a distance of 380 yards. East Street: west side-from the junction with Brighton Road, northwards for a distance of 22 yards. East Street: east side-from the junction with Brighton Road, northwards for a distance of 43 yards.
In the Urban District of Southwick
Albion Street: north side-from the junction with Kingston Lane, eastwards for a distance of 17 yards.

Albion Street, south side-from the junction with Kingston Lane, eastwards to the junction with Colebrook Road.

Park Lane: south side-from the junction with Victoria Road, westwards to the junction with Kingston Lane.

## Second Schedule

(waiting limited to 60 minutes in any two hours between the hours of 9 a.m. and 6 p.m.)
In the Urban District of Shoreham-by-Sea
East Street: west side-from a point 22 yards north of the junction with Brighton Road, northwards for a distance of 90 yards.

(waiting prohibited between the hours of 9 a.m. and 6 p.m.)
In the Urban District of Shoreham-by-Sea
New Road: north side-from a point 37 yards east of the junction with East Street, eastwards to the junction with Tarmount Lane.

## Fourth Schbdule

(waiting prohibited between the hours of 8 a.m. and 8 p.m.)
In the Urban District of Southwick
Albion Street, north side-from a point 10 yards east of the junction with Victoria Road, eastwards to the junction with Colebrook Road.

Grange Road: west side-from the junction with Albion Street northwards for a distance of 110 yards.

In the Urban District of Southwick

## Length of Road and Direction

Spring Gardens at its junction with White Rock Place. In such direction so as to keep the traffic isiand on the right or off side.
