### TOWN AND COUNTRY PLANNING ACT 1962

*Altrincham, Ches*

The Minister of Transport hereby gives notice that she proposes to make an Order under section 153 of the above Act to authorise the stopping up of lengths of Springfield Road, Mart Street, Clifton Avenue, Linden Avenue and the whole of Meadow Bank Terrace, Altrincham, Cheshire, to enable development consisting of the construction of a level crossing by-pass to be carried out by Altrincham Borough Council under Part III of the Act.

The proposed Order will require the provision of new roads.
