## NORTHAMPTONSHIRE COUNTY COUNCIL

*The County of Northampton (Upper Heyford to Nether Heyford Road) (Restriction of Driving) Order, 1967.*

Notice is hereby given that the Northamptonshire County Council have applied to the Minister of Transport for confirmation of an Order made by them under section 1 of the Road Traffic Regulation Act, 1967, the effect of which will be that no person shall cause any vehicle the weight of which, whether laden or unladen, exceeds three tons to proceed in the road from Upper Heyford to Nether Heyford. Exceptions are provided in the Order to enable vehicles to proceed in the road in question if the vehicle is being used:

- (a) for the conveyance of persons, goods or merchandise to and from any premises situated on or adjacent to that road;
- (b) for purposes of agriculture in connection with land adjacent to that road or for the conveyance or haulage of timber felled upon that land; or
- (c) in connection with any funeral, building operation or demolition in or adjacent to that road, the removal of any obstruction to traffic in that road, the maintenance, improvement or reconstruction of that road, or the laying, erection, alteration or repair in or adjacent to that road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act, 1878.
