TOWN AND COUNTRY PLANNING ACT 1962

The Secretary of State hereby gives notice that he proposes to make an Order under section 153 of the above Act to authorise the stopping up of a length of footpath at Ffordd Isa, Prestatyn, Flintshire in order to enable residential development to be carried out in accordance with planning permission granted to N.
