## PUBLIC HEALTH ACTS AND CLEAN AIR ACT

### BIRKENHEAD COUNTY BOROUGH COUNCIL

*The Birkenhead (Area No. 6 Bidston Hill) Smoke Control Order, 1967*

Notice is hereby given that the Birkenhead County Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956 on the 25th day of October 1967, made an Order entitled "The Birkenhead (Area No. 6 Bidston Hill) Smoke Control Order, 1967" declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exceptions provided by the Order and by virtue of section 11 (4) of the Act if on any day after the Order has come into operation smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Town Hall, Birkenhead, at all reasonable times during the period of six weeks from the 27th day of November 1967.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

#### SCHEDULE

*Area*—Approximately 269 acres.

*Boundary*—Enclosed by a line from Bridge Farm, eastwards along Upton Road, Thermopylae Pass, Upton Road, then northward along Boundary Road, Hoyle Road, then in a southerly direction along the rear boundaries of Church and Ivy Farms the rear gardens of houses in Eleanor Road and Westwood Road and Upton Road to Bridge Farm.

### WEST BROMWICH COUNTY BOROUGH COUNCIL

Smoke Control Order No. 17, 1967*

Notice is hereby given that the County Borough of West Bromwich, in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, on the 6th day of November 1967, made an Order entitled the County Borough of West Bromwich Smoke Control Order Number 17, 1967, declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act, if, on any

day after the Order has come into operation smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10, unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before the 1st October 1968, or before a later date determined by the Minister of Housing and Local Government.

A copy of the Order and of the map referred to therein may be inspected, free of charge, at the Town Hall, West Bromwich, at all reasonable times during the period of 6 weeks from the 24th November 1967.

Within the said period any person who will be affected by the Order may, by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

### ECCLES BOROUGH COUNCIL

Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before the 1st day of July 1969, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Town Hall, Eccles at all reasonable times during the period of six weeks from the 23rd November 1967.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

Notice is also given that the Eccles Borough Council in exercise of the powers conferred upon them by section 95 (2) of the Housing Act, 1964, have designated open grates capable of burning only open grate fuels as being, in their opinion, unsuitable for installation in the above-mentioned area, as tending by reason of their consumption of such fuels, to impose undue strain on the fuel resources available for this area and grant will not, therefore, be payable on the installation of this class of heating appliance.
