The QUEEN has been graciously pleased to give and grant unto the Anglia Building Society Her Majesty's Royal Licence and Authority that they may bear and use, in their corporate capacity on their Common Seal or otherwise according to the Laws of Arms, certain Armorial Ensigns which were granted and assigned unto The Northampton Town and County Building Society by Letters Patent under the hands and Seals of Garter, Clarenceux and Norroy and Ulster Kings of Arms bearing date the 10th day of September 1956: the said Arms being first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms: otherwise the said Royal Licence and Permission to be void and of none effect.
