2. To prohibit the waiting of vehicles between 8.30 a.m. and 6 p.m. on each day of the week throughout the year on the following lengths of road at Burnham-on-Crouch:

- (a) High Street (B.1021)
 (i) on the northern side from the existing restriction north-westwards for a distance of 10 yards; and
- (ii) on both sides from the existing restriction eastwards for a distance of 10 yards.
 (b) Chapel Road—on both sides from its junction with High Street northwards for a distance of 20 yards.

(d) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said lengths of road.
