WEST RIDING OF YORKSHIRE COUNTY COUNCIL

The County Council of the West Riding of Yorkshire (Un-named Road Connecting Broomfield Road and Bracken Moor Lane, Stocksbridge) (One-Way) Order, 1967.

Notice is hereby given that the County Council of the West Riding of Yorkshire propose to make an Order under the Road Traffic Regulation Act, 1967 the effect of which will be that no person shall drive or cause or permit to be driven any vehicle on the un-named road connecting Broomfield Road and Bracken Moor Lane at Stocksbridge, in the Stocksbridge Urban District, otherwise than from east to west. An exception in the Order will enable the use of mechanical road cleansing vehicles between the hours of 7.30 a.m. to 5 p.m.
