Notice is hereby given in pursuance of section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture, Fisheries and Food has made the following Order:

(Statutory Instruments 1967 No. 1723)

The Foot-and-Mouth Disease (Controlled Areas Restrictions) (Amendment) Order 1967

In a foot-and-mouth disease Controlled Area, cattle, sheep, goats, pigs and deer may not be moved without a licence from an inspector of a local authority. This order, which came into operation on 22nd November 1967, prevents unsold animals in a fatstock market, fair or sale, or in a certification centre, from being licensed to be moved back to premises from which they were brought; a licence may now only authorise their removal direct to a slaughterhouse.
