

wer has his Quarters at Mulberg, part of his Troops are posted behind the Lines of Dixland, and the rest extend themselves as far as the Black Forest. The Duke of Wirtemberg's Forces lye in that Forest to cover his own Country; and the Count de Merici is at the head of a large Detachment on the Tobel, 16 Leagues from this Place. The Inhabitants of the adjacent Country are order'd to have 3000 Horses in a readiness, and to provide Carriages for the Artillery. These Preparations very much perplex the Enemy, and oblige 'em to harass their Troops by frequent Mursions and Counter-marches. Some of those which they had sent to the Moselle are recall'd; and they have undermin'd their Works near Lauterburg, in order to blow 'em up at the Approach of the Elector. General Thaugen being indispos'd, has retir'd to his Seat at Freudenthall. Prince Eugene's Regiment of Dragoons, and a Party of Hussars who arriv'd yesterday in the Neighbourhood of this City, are to march towards the Moselle. On the 22d instant twelve Regiments, consisting of Imperialists and Palatines, pass'd the Rhine at Mayence, and are to march to the same Rendezvous. A great Train of Artillery is preparing for the Service in these Parts, and a few of Mayence has undertaken to bring in the 200 Waggon, and 3000 Horses, which the Circle of the Upper Rhine is engag'd to furnish.

From the Camp at Terbanck, June 28. N. S. Yesterday both Lines of the Army were drawn out; in the Morning his Grace the Duke of Marlborough rode along the first with the Electoral Prince of Hanover, attended by the General Officers; and after dining with Lieutenant-General Lawley, they came back in the Front of the second Line; his Highness being very well pleas'd at so fine an Appearance. An Express arriv'd here Yesterday with Letters to his Grace from Prince Eugene, giving an Account, That his Army would be assembled to Morrow, the 29th; the Difficulties about the March of the Palatins Troops being at last remov'd. Our Partisan Parties have lately been very successful, one of them brought in on Tuesday last 40 Troop-Horses, which they took from the Enemy on a Forage.

Hague, June 29. N. S. The Prince Hereditary of Courland is expected here within few Days. The States have ratify'd a Treaty concluded between their high Mightinesses, and the Republicks of Algier, Tunis and Tripoli. We hear from the Lower Rhine, that the Elector of Bavaria is still at Saar Louis, and had sent back the last Detachment, which had join'd him from the Rhine. Letters from France inform us, that they had receiv'd Advices from Spain, that the Duke of Orleans had not made any Attempt upon Tortosa, and that the Duke de Noailles had retir'd towards Roses, from whence he has Orders to detach some Troops for the Service in Provence.
