Notice is hereby given that the Blackburn County Borough Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967 the effect of which will be to prohibit the waiting of vehicles at any time in the lengths of road set out in the First Schedule, and to restrict the waiting of vehicles on weekdays to one hour in any period of two hours between 7 a.m. and 7 p.m. in the lengths of street set out in the Second Schedule.

The usual exemptions will apply. Objections to the proposals must be sent in writing to me by 1st January 1968.

Lammack Road	South.	Revidge Road to the westerly boundary of 39 Lammack Road.
Lammack Road	North.	Pleckgate Road to the westerly boundary of No. 16 Lammack Road.
Pleckgate Road	Both.	Shear Brow for a distance of approximately 125 feet.
Revidge Road	North.	Lammack Road for a distance of approximately 125 feet.
Revidge Road	South.	Shear Brow for a distance of approximately 50 feet.
Shear Brow	East.	Pleckgate Road to a point opposite the southerly gable of 240 Shear Brow.

THE SECOND SCHEDULE

Street	Side	Length
Revidge Road	South.	From a point approximately 50 feet from Shear Brow for a distance of approximately 75 feet.
Shear Brow	West.	Revidge Road to a point opposite the southerly gable of 329 Shear Brow.
