The QUEEN has been graciously pleased to approve the following awards for gallant and distinguished services in Aden:

Military Cross

Lieutenant Terence Peter Phayre KNOTT, Royal Marines.

Early on the morning of 30th May 1967, Lieutenant Knott was commanding the Reconnaissance Troop of 45 Commando Royal Marines, which was the emergency standby troop at Hailayn Aden, and was at fifteen minutes notice to move.

Lieutenant Knott reported the troop ready to move within five minutes of news of an ambush. Despatching four men in a Scout helicopter to act as picket for the ambush position, he explained with the remaining fifteen men in a Wessex helicopter.

After orbiting the area whilst fighter strikes were put in, the Wessex was directed on to a landing point believed to be clear of enemy and to the north of their position.

As the Wessex came into the hover over the landing point, it was plain that the site selected was in the middle of the enemy position. The pilot of the helicopter was unable to land owing to heavy rifle and machine gun fire. Lieutenant Knott decided to deplane his troop, who jumped out on to rugged and precipitous rocks whilst the helicopter was still some ten to twelve feet from the ground. They immediately came under fire, not only from the enemy on whose positions they had landed, but from other strong enemy supporting positions behind them on the top of the Jebel Lahmahr. This ridge completely dominated the landing point. Led by Lieutenant Knott the troop killed one dissident on landing and then moved into a steep gully to avoid the fire from the Lahmahr. As they did so a dissident emerged from a small cave and fired two rounds with an automatic rifle at Lieutenant Knott at point black range. Lieutenant Knott and one of his troop fired back and the dissident, having been hit, withdrew to a sangar in the cave. Approaching the cave from the side Lieutenant Knott threw in an M26 grenade which the dissident picked up and threw back. Avoiding the explosion which followed, Lieutenant Knott, completely regardless of his own safety, went into the cave and personally shot the dissident dead.

Lieutenant Knott's outstanding example of personal bravery and his coolness and judgment under continuous heavy fire greatly inspired his troop, which included a number of young marines who had not been in action before. The determined action of his troop effected the relief of the Sappers who were still under fire. Finally the casualties inflicted on the enemy were so severe that this dissident group withdrew from the Federation. The action took place immediately before the period covering the withdrawal of British Forces from the Federation and undoubtedly deterred the enemy from further action at this critical time.

Lieutenant Knott's gallantry, his very professional example and his coolness and judgment whilst in action were of the highest order.

Distinguished Service Order

Lieutenant-Colonel Peter Aldcroft DOWNWARD (299293) The Lancashire Regiment (Prince of Wales's Volunteers).

Lieutenant-Colonel Downward arrived in Aden with a young and inexperienced battalion. He immediately got down to the problem of welding his battalion into an efficient fighting unit.

His arrival coincided with a particularly difficult phase of Internal Security operations when the terrorists were better trained and the tempo of operations considerably increased. However the high level

of efficiency to which he had trained his men was clearly shown by their alertness on patrol, and in observation posts by day and by night, and in their quick reaction to terrorist attacks. His tactical handling of the battalion and the organisation behind his operational control were only achieved by a remarkable capacity for work.

His quiet determined approach led him to ignore the risk of assassination during the many visits he made, very often at night, to small parties of soldiers in isolated and dangerous areas in the back streets of the native quarters.

He took over command of Aden Brigade for four weeks immediately after the rioting in the Federal Forces and the Crater murders and disturbances, when the terrorists took over the town. His calmness and handling of the difficult and delicate situation not only contributed to the maintenance of law and order in the other areas of Aden, but enabled a situation to be created whereby British Troops re-entered Crater without loss of life. His period in command of the Brigade coincided with a most difficult and politically delicate period of the emergency; the way in which he took over his duties quickly earned the trust and confidence of his superiors, his staff and the units under his command and was a measure of his ability and dedication to his task.

His professional ability, high sense of duty, quiet determination and disregard for his own safety both when commanding his own battalion and while temporarily commanding the Brigade have been in the very highest traditions of the service.

Distinguished Service Order

Lieutenant-Colonel Michael John Hatley WALSH (364588) The Parachute Regiment.

On arrival in Aden, Lieutenant-Colonel Walsh was immediately ordered to take up defensive positions in Sheikh Othman and Mansoura which comprised the battalion area. This was a completely new tactical concept resulting from a rapidly deteriorating operational situation.

On 1st June 1967, the terrorists carried out a series of heavy attacks on the observation posts and a continuous fire fight took place all day. During this period Lieutenant-Colonel Walsh visited the posts and mobile units, directing operations from his Rover vehicle. He was under fire many times throughout the day and his coolness and leadership was an inspiration to all his soldiers. This, together with his skilful handling of the battalion group enabled the situation to be stabilised and defeated the terrorists' attempt to take over the town.

On 5th June 1967, a major attack was made by the terrorists on the Sheikh Othman Police Station. Lieutenant-Colonel Walsh immediately dispatched a platoon to the area. At the same time the force occupying the disused Mission Hospital on the fringe of Sheikh Othman was pinned down by heavy terrorist fire and unable to assist in the relief of the Police Station. Lieutenant-Colonel Walsh immediately ordered a company from the battalion base and personally led this force into the Mission Hospital and under heavy and continuous fire relieved the hard pressed force in the Hospital. Having secured the Hospital, Lieutenant-Colonel Walsh reorganised the defence of the perimeter and spent the rest of the day, frequently under fire restoring the situation throughout his area. His complete disregard for his own safety and skilful handling of the many components of his battalion group won him the admiration of all ranks.

At 1030 hours on 20th June 1967, the Federal Guard stationed at Champion Lines, which is adjacent to 1st Parachute battalion's main base, mutinied and brought increasingly effective and heavy fire to bear on Radfan Camp, the battalion main base. In order that the situation might be restored Lieutenant-Colonel Walsh immediately gave orders that fire was not to be returned and that all ranks should take cover. Disregarding the latter part of his own orders, he visited the positions on the perimeter, including the guard-room which was under extremely effective fire, and talked and joked with the soldiers whilst explaining the vital reasons why fire should not be returned. There is no doubt that his presence and handling of this situation had a stabilising effect on his soldiers and prevented the aggravation of a most difficult situation. In addition he brilliantly organised the sending of one of his companies to secure Champion Lines, which was completely successful.

By his outstanding devotion to duty, personal bravery and exceptional powers of command,

Lieutenant-Colonel Walsh has contained the situation in Sheikh Othman whilst never departing from the principle of minimum force.

Military Cross

2nd Lieutenant Richard Derek Lloyd VAUGHAN-GRIFFITH (482861) The Queen's Own Hussars.

During the morning of 8th September 1967, in the built up dormitory area of Mansoura in Aden, a fourteen-man patrol of 1st Battalion, The Lancashire Regiment reported that they had come under heavy fire from a number of points and had been forced to take cover in two houses.

A half troop of the Queen's Own Hussars commanded by Second Lieutenant Vaughan-Griffiths set out from a firm base to give them supporting fire. The troop leader could not determine the exact location of the patrol as it was out of communication with its company base. With his armoured car and scout car he scoured the area of the patrol's intended sweep; and in a section where there was some red smoke he saw a beret sticking out of a window on a stick. Reversing his Saladin armoured car toward the house under heavy small arms fire from approximately ten firing points, he determined by personal contact that the patrol was in two groups, the location of the second group being unknown to the first.

Acting on his own initiative, he called up a Saracen Armoured Personnel Carrier from his base which he then ordered to reverse up to the house and embussed the half patrol which included two casualties. He positioned his two cars between the terrorist fire and the house to act as a shield during embussing whilst he returned the fire. He evacuated the half patrol to a safe base and then immediately returned to locate and rescue the remaining section. From intermittent infantry radio reports he determined their general area and once more under heavy fire repositioned his Saracen, ordered his scout car to cover certain firing points while he dealt with others. The remaining infantry were subsequently embussed and escorted to safety without further casualties.

The operation lasted two hours; during this time Second Lieutenant Vaughan-Griffiths, whilst his armoured cars were frequently under heavy and accurate small arms fire acted with great initiative, personal bravery and presence of mind. His only concern, in spite of operating his cars with no infantry support in an area with a known anti-tank mine threat, and while vulnerable to surprise short range bazooka and grenade attack, was to rescue the infantry patrol before they suffered further casualties. That he achieved this self-set task successfully under the most difficult operational conditions is the measure of his outstanding example of courage, leadership and determination.

Military Cross

Lieutenant Michael John CONROY (480271) Corps of Royal Engineers.

Lieutenant Conroy was in command of a party which had set off from Hailayn, South Arabia to carry out repair work on the road from Hailayn to Aden. The party consisted of a convoy of engineer equipment, tippers, small vehicles and a Saracen armed personnel carrier. It also included two small piquets of Federal National Guard. At about 0815 hours the leading group of vehicles ran into a strong dissident ambush and came under heavy fire from close range and from the surrounding Jebels with rockets, machine gun and rifle fire.

On hearing the firing Lieutenant Conroy, travelling with the second group of vehicles halted them and reported the contact to his Headquarters. He found that he was unable to contact the ambushed vehicles by radio. So regardless of his own safety he drove his rover group into the ambush area to take command, even though he knew that he would be under heavy fire. By this time many men were injured and the 300 yards length of the ambush was under constant and accurate fire. Lieutenant Conroy first reorganised the men for their better protection and, in order to bring effective fire to bear on the enemy, he brought forward a light machine gun which he sited before handing it over to a soldier and despatched another soldier to establish contact with the Federal National Guard piquet who had taken up fire positions in the jebel above him. He then called for Hunter Strike aircraft by radio.

By this time he and his radio operator were wounded and Lieutenant Conroy moved the latter to a safe area. He then returned to his wireless

vehicle, gave details of the enemy positions for fighter ground attack aircraft. He remained in this exposed position, sending target adjustments until his radio was put out of action. He then ran along the side of the road to another radio vehicle in order to re-establish contact with the aircraft.

For over an hour Lieutenant Conroy had been in an exposed position in an area being swept by small arms fire. When his commanding Officer arrived at the scene, Lieutenant Conroy had to be ordered to move to a safe area to await evacuation.

By his great coolness and presence of mind and by showing great personal courage and initiative, this young and inexperienced officer showed inspiring leadership and was an outstanding example to his men.

Military Cross

Major David Edwin MILLER (418335) The King's Own Royal Border Regiment.

From 5th June to 22nd July 1967, Major Miller commanded "C" Company, First Battalion, The King's Own Royal Border Regiment, on operations in Aden. Throughout the period the Company was under the operational command of the First Battalion, The Parachute Regiment.

On Tuesday, 20th June 1967, the Company was the "stand by force" for the area and was based in Radfan Camp. Early that morning firing broke out in Champion Lines, a Federal National Guard Barracks approximately 300 yards from Radfan Camp. At approximately 1000 hours, at the request of the South Arabian Federal Government, the Commanding Officer, 1 Para, was ordered to send a company to secure the main armoury in Champion Lines and to protect the British Officers besieged in the Barracks.

Major Miller was ordered to carry out this difficult task, assisted by a troop of the Queen's Dragoon Guards. Quickly he gave out preliminary instructions to his Officers and senior Non Commissioned Officers. He then moved out with a small protection party in a Saracen to make contact with the senior British Officer in Champion Lines before completing his plan. Whilst there the situation worsened and the Company was ordered to move forthwith. The move was made in 3 ton vehicles which came under fire from Champion Lines shortly after leaving Radfan Camp. One man was killed and eight wounded. Major Miller, with considerable skill and regardless of his own safety, deployed his Company and assisted by the armoured cars of the Queen's Dragoon Guards entered the Barracks. The sudden appearance of British troops quickly restored law and order in Champion Lines. It was achieved without any fire being returned by the Company and only a limited amount of fire from the armoured cars. "C" Company, First Battalion, The King's Own Royal Border Regiment took up positions around the main armoury, the Guard Room at both main entrances and made contact with the British Officers besieged in the Camp. They remained in their positions until ordered to withdraw at the request of the Federal Authorities at 1530 hours.

The professional and decisive manner in which Major Miller handled his Company during this difficult operation undoubtedly prevented a great deal of bloodshed, saved the lives of a number of British seconded and contract Officers and played a major part in preventing the mutiny of the Federal National Guard spreading throughout Aden and the Federation. His leadership and courage was an inspiration and outstanding example to his men and in the very highest traditions of the Service.

Military Cross

Lieutenant David John CLEARY (480267) The Lancashire Regiment (Prince of Wales's Volunteers).

Lieutenant Cleary is a rifle platoon commander in the 1st Battalion The Lancashire Regiment (Prince of Wales's Volunteers). On 8th September he was briefed to carry out a patrol in the Al Mansura area in order to ensure that the main route was kept clear of interference from terrorist sniping.

At approximately 0900 hours the Platoon Sergeant noticed a look-out, presumed to be a terrorist, on the roof of a building singled out for particular attention. Lieutenant Cleary immediately ordered a quick cordon round the block and placed sentries with light machine guns on rooftops while a search of the building was made. Shortly after this the cordon came under fire from a position about 200 yards away. Lieutenant Cleary immediately deployed

his party into fire positions within the building and on the roof in order to support the cordon party. A fierce fire fight developed with further terrorist firing points, approximately ten in all, opening up on three sides of him. The route into the area from the East still remained open and on instructions over the radio from the company commander the patrol was ordered to pull back to the line of the main road where they could be given better support from the armoured cars. In the process of leapfrogging the patrol groups back along the line of buildings the radio was put out of action and two men were wounded. Lieutenant Cleary then used smoke to get the casualties under cover though they were virtually separated from the main part of the patrol by a lane of heavy fire. Attempts were then made by the terrorists to cut off the patrol before it got to the road and the cover of the armoured cars. The patrol was virtually surrounded and under intense fire from every direction.

By a series of signals and careful control of his fire, Lieutenant Cleary was able to guide the armoured cars to his most heavily pressed group of men looking after the casualties. Having seen them safely away he then consolidated his position in order to exercise greater control, particularly on ammunition which at this stage was starting to run low. The armoured cars again returned to the position and under very heavy fire from both sides the patrol was finally withdrawn at approximately 1240 hours after a battle lasting nearly two and a half hours against a numerically superior and well equipped enemy. The terrorists suffered six killed and seven wounded.

Lieutenant Cleary showed outstanding bravery in his complete disregard for his own safety, and by his quick reactions undoubtedly saved further casualties amongst his own men.

Military Cross

Major Ian MACKAY (440088) The Argyll and Sutherland Highlanders (Princess Louise's).

From 29th June to 26th August 1967, Major Mackay has commanded D company, 1st Battalion, The Argyll and Sutherland Highlanders in a continuous operation embracing the re-entry into the Crater district of Aden and the subsequent military occupation of that town. On 20th June, while with the Battalion Advance Party, he took over command of the advance elements of D company when the Company Commander was ambushed and killed. This was followed by a week of intensive observation and patrolling on the periphery of Crater. In the ensuing operation to re-occupy Crater, Major Mackay was conspicuous by his enthusiasm and tactical ability. He handled his Company with exceptional skill when required to organise and execute two night operations to secure key positions in the heart of the town. His clear-cut briefings and sound personal leadership displayed a professional competence of the highest order.

For the ensuing eight weeks he continued to command his Company in a unique situation, where they lived cheek by jowl with a civilian population estimated at 40,000 people within the company boundaries. During this time hostile elements carried out a total of forty attacks within his area using 2 inch mortar bombs, automatic weapons, rockets, grenades and mines. He personally followed up each one of these and was responsible for the certain killing by his Company of twelve suspected terrorists and the arrest of several more. This strict enforcement of law and order led to the complete military domination of the Company area.

On 21st July a terrorist sniper engaged one of the Company observation posts and killed the Non Commissioned Officer manning the general purpose machine gun. Major Mackay restored the situation by occupying the Observation Post himself and directing the cordon party by radio. By such personal gallantry under fire he kept the morale of his Company at the highest level. Again, on 5th August, a blindicide rocket was fired at his Company Headquarters, narrowly missing him. He personally led the nearest soldiers to hand in a quick dash towards the suspected firing point. A second explosion, this time a grenade, fortunately blew up on the spigot and he and his small party were unhurt. He was able to find the electrical detonating equipment still intact and trace the wires to the firing point, which led to the arrest of two suspected terrorists. His complete disregard for his own safety and his spirited leadership were an example to all ranks.

In addition to his personal courage Major Mackay displayed high moral courage when faced with situations where firm and timely action prevented the spread of terrorism and he was required to execute difficult orders which carried grave responsibility. His tactical control and expertise were outstanding and his personal example was an inspiration to his officers and men in the highest traditions of the British Army on Internal Security duties.

Military Cross

Captain Edward Charles LODEN (464666) The Parachute Regiment.

Captain Loden is the Intelligence Officer of the 1st Battalion, The Parachute Regiment stationed in Aden. This young Officer, besides carrying out his normal task, showed exceptional coolness, courage and devotion to duty on three separate occasions during June 1967.

On the 1st June 1967, the terrorist organisation in Aden called a general strike. Early that morning shooting broke out in Sheikh Othman and a violent battle was fought all day between a large number of terrorists and roof top observation posts manned by 1st Battalion, The Parachute Regiment. By early afternoon our positions were short of ammunition, Captain Loden, who knew the best routes and entrances to all the observation posts, immediately offered to take an armoured vehicle and replenish all our positions with ammunition and water. Regardless of his own personal safety and often having to expose himself to sniper fire, he succeeded in his task. His action helped considerably to ensure the victory of our troops in Sheikh Othman that day. Finally that evening Captain Loden was placed in charge of a group of armoured vehicles sent to recover the observation post parties and replace them with fresh troops. This recovery operation was carried out skilfully and without incident. Throughout the whole day this young Officer's conduct and personal bravery was of the highest order. He set a fine example and was an inspiration to all.

In June 1967, Captain Loden, acting on his own initiative, obtained information that a certain house in Sheikh Othman was being used by terrorists as headquarters. He followed this up and, by the 27th June, he was able to give his Commanding Officer complete details. Acting on this information an operation was ordered for late that night. The raid, carried out by a platoon of D (Patrol) Company, 1st Battalion, The Parachute Regiment and a platoon of 1st Battalion, The King's Own Royal Border Regiment, was directed and co-ordinated by Captain Loden. It transpired that the house was being used by the National Liberation Front as a secret hide-out in which to keep kidnapped members of the Front for the Liberation of Occupied South Yemen, the rival terrorist organisation. On the arrival of our troops the National Liberation Front guard shot his four prisoners, killing two and wounding two. He then tried to escape but was shot and captured. The whole operation was carried out with great skill. Its success was primarily due to Captain Loden's determination and perseverance in gaining the information and following it through with a well directed and co-ordinated raid.

On Tuesday 20th June 1967, Captain Loden was commanding one of three officer led patrols sent out of Radfan Camp in armoured three ton vehicles, to search for and recover, wounded and dead in the area of the sand dunes outside Champion Lines following the mutiny of the Federal National Guard. In spite of the area still being under fire the Officer personally recovered bodies from an exposed three ton vehicle belonging to 60 Squadron, Royal Corps of Transport. Throughout Captain Loden showed considerable personal bravery and a high standard of leadership.

Military Cross

Lieutenant James Alastair MCGREGOR (474006) The Parachute Regiment.

Lieutenant McGregor was the Commander of a detachment of the Mortar Platoon, First Battalion, The Parachute Regiment, which was due to take over duties in the observation post in the tower of Sheikh Othman Police Station on 7th September 1967. As there was to be a general strike on that day, the detachment was ordered to its task twelve hours early at short notice.

At 2200 hours, when the detachment arrived at the Police Station, the observation post was under

spasmodic fire, which continued throughout the night. At first light the enemy fire became both heavy and accurate. Four times armoured cars had to be deployed to relieve the pressure, and restore the fire initiative. During the day Lieutenant McGregor displayed great coolness and leadership. His professional skill, fire control and observation was an inspiration to all his men.

On 9th September 1967, Lieutenant McGregor was still with his detachment in the Police Station, when intense interfacational fighting broke out. For long periods of time the observation post was in cross-fire of small arms, blindicide rockets, and mortars, and the security of the garrison of the Police Station gave grounds for concern. Under Lieutenant McGregor's leadership his men maintained an extremely high standard of alertness and observation, and their reading of the situation provided much valuable information, which was gained often under heavy fire.

During 9th-11th September 1967, Lieutenant McGregor worked in very close liaison with the Civil Police in the preparation and production of a peace broadcast, which eventually led to a cease fire. He then volunteered to remain in the Police Station so as to make best use of the liaison, which he had set up during his stay, as another general strike had been called for on 12th September 1967.

From 6th September until he was relieved on the night 11th-12th September, Lieutenant McGregor handled the situation with skill, firmness, tact and enthusiasm. During the first thirty-six hours his coolness, control and professional skill set a fine example under heavy fire. At no time did he show anything other than complete confidence, and his actions throughout showed a clear understanding of the military and political situations. Lieutenant McGregor's leadership, encouragement and the discipline of his men did much to maintain the morale and loyalty of the Civil Police at a very difficult time.

Military Cross

2nd Lieutenant Nicholas Embleton EMSON (482168) The Parachute Regiment.

Second Lieutenant Emson is the Platoon Commander of 8 Platoon, "C" Company, First Battalion, The Parachute Regiment. On Thursday 1st June 1967, there was a general strike throughout Aden. "D" Company, with under command 8 Platoon, was deployed in roof top observation posts throughout Sheikh Othman. Second Lieutenant Emson was in command of Observation Post 12. Shortly after first light all observation posts were engaged by accurate and intensive small arms fire, in many cases from as close as 50 yards range. This fire fight went on continuously for nearly five hours. Tragically 8 Platoon's machine gunner was fatally wounded and shortly after it became impossible for the armoured cars to give the observation post supporting fire. Orders were given for the position to be evacuated and the Platoon to move to another nearby observation post. After seeing his casualty safely evacuated by armoured ambulance Second Lieutenant Emson successfully withdrew the platoon without incident. Throughout the remainder of the day and until long after last light his platoon continued the fight from their new position.

Second Lieutenant Emson's personal example and leadership was an inspiration to his men. Throughout the day his courage and coolness under fire was in the highest traditions of the Army.

On Tuesday 20th June 1967, Second Lieutenant Emson's Company was the Internal Security Company in Radfan Camp. That morning there had been an armed uprising of the Federal National Guard in nearby Champion Lines. "C" Company of the King's Own Royal Border Regiment were ordered to move to these lines to secure the main armoury and to restore law and order. In doing this they suffered a number of casualties. In addition there were unconfirmed reports of other British casualties lying out in the sand dunes, an area still swept by fire from Champion Lines.

Second Lieutenant Emson was ordered to take one of three officer led patrols to go out, search for and recover any wounded or dead in the area. He took a party of four men and an armoured 3 ton vehicle. They found two wounded soldiers but soon after came under heavy fire. This punctured the radiator and front tyres causing the vehicle to slew across the road and face directly towards

Champion Lines. The next burst of fire entered the drivers visor, the hatch of which had been jammed, wounding the driver and three men in the vehicle. Second Lieutenant Emson, without thought of his own safety, pulled the driver out of his seat and managed to turn the vehicle out of the direct line of fire. He then took over the radio and, even though his head set was shot off his head, undaunted continued to pass clear and concise reports back to Battalion Headquarters. Finally, when the firing ceased, he supervised the recovery of his disabled vehicle and the evacuation of his wounded men to hospital. Throughout the action, this young Officer showed exceptional bravery and devotion to duty. His courage and quick action undoubtedly saved many men's lives.

Military Cross

Reverend Robin Roe (445206) Chaplain to the Forces 3rd Class Royal Army Chaplains' Department.

The Reverend Roe volunteered for duty as a Chaplain with the 1st Battalion The Lancashire Regiment in order to accompany the Battalion on a nine month operational tour in Aden. Throughout the tour he has created a deep impression on all ranks in the Battalion by his example, courage and force of personality. Where ever the soldiers have been in action no matter how dangerous or unpleasant the task, he has always been there or has been quickly on the scene.

During the Battalion's operations in Tawahi he accompanied patrols on numerous occasions in and out of the slum area and grenade alleys, both by day and by night, sharing with the men the threats of the terrorist weapons with a coolness that inspired in every man a tremendous self-confidence. He was always quickly on the scene of an incident ready to give assistance to any casualties, and on at least two occasions involving grenade attacks, he was involved in the incidents themselves.

He played a particularly gallant part during the "Aden Mutiny" on 20th June when, oblivious to the heavy fire being directed at the camp, he attempted to drive about 400 yards across open desert to the scene of an incident where several men had been killed and some badly wounded. He was turned back forcibly by another officer only after he personally had been shot at and his Land Rover hit by machine gun fire. He then devoted his attention to assisting the Medical Orderlies inside camp with the local casualties until it was possible to recover the victims of the main attack.

With the change of operational commitment to Al Mansure, a hostile area much given to heavy shooting exchanges, the Reverend Roe has gone far beyond the call of a Chaplain's duty to assist and inspire the men of the Battalion in the time of danger. He has accompanied men on patrol in the face of strong enemy reaction on numerous occasions, at least three of which were under extremely heavy small arms fire and accompanied by grenade attacks. By virtue of his appointment he has not been able to retaliate even to defend himself, nevertheless he has shown complete disregard for his own safety, and has displayed a coolness and air of confidence which has inspired every officer and soldier around him. His concern for the safety of the soldiers, particularly on becoming casualties, has become a byword to every man in the Battalion, and his comfort to next of kin of men seriously wounded or killed in action has had the most profound effect in the maintenance of morale in the Battalion.

His courage and example in the face of danger has been outstanding and his infectious enthusiasm and confidence under all conditions has been an inspiration to the whole Battalion.

Distinguished Flying Cross

Lieutenant (acting Captain) David John RALLS (472605) Royal Corps of Transport (serving with Army Air Corps).

Early in the morning of 30th May 1967, a convoy of Royal Engineer vehicles was ambushed by a dissident force of about thirty men in the Wadi Matlah in the Haushabi province of the South Arabian Federation. An urgent call was received at the command post of 13 Flight Army Air Corps at Habilayn for two helicopters; one in an armed role and the other to evacuate casualties. Although not officially on stand-by Lieutenant Ralls and his gunner were air-borne in an armed Scout over Habilayn in seven minutes.

He reached the ambush position five minutes later. As he was unable to get in touch by radio with the ambushed troops, Lieutenant Ralls landed in what appeared to be dead ground in order to obtain an up-to-date report. The aircraft was immediately shot at and Lieutenant Ralls took off to pinpoint the source of fire.

Firing at the Scout continued, but it was some minutes before the enemy position was located. In order to indicate the target to Fighter Ground Attack aircraft which were over the area, Lieutenant Ralls flew over it and his gunner engaged it. At this stage his Scout was hit by enemy small arms fire. Notwithstanding, Lieutenant Ralls circled to drop a smoke grenade to mark the enemy position and then directed three Hunter strikes on to it.

When the strikes were completed, Lieutenant Ralls tried to observe their effect and again came under fire from an unseen position. He continued to engage the enemy, who could be seen in the area of a cave, until the arrival of troops from 45 commando Royal Marines in a Wessex helicopter. Although still under fire, the Scout led the Wessex in to a landing point just above the cave. As a result of this operation three enemy dead were subsequently recovered.

Lieutenant Ralls then landed in the ambush position and, after lifting out four of the casualties, he returned to Habilayn to re-fuel. It was then discovered that owing to the damage it had suffered from enemy fire, his aircraft was no longer air-worthy. With his gunner, Lieutenant Ralls transferred to another Scout and immediately returned to the area of operations, where throughout the day he provided general support for the follow-up troops. This support involved many landings in very rugged terrain calling for considerable skill and courage on his part.

The very high temperature and the height of the jebels on which this operation took place made flying most difficult. Coupled with the resolution shown by the enemy, this made conditions extremely hazardous.

Throughout the day, under the most exacting circumstances, Lieutenant Ralls displayed the highest standards of flying. Largely due to his determination, coolness, and military judgment it was possible to extricate the engineers from the ambush position. Furthermore his control of the strike aircraft and his selection of a landing point for the Wessex were instrumental in causing at least two, and probably more, enemy casualties.

The courage, flying skill and initiative displayed by this very junior officer throughout the action were of the highest order and a magnificent example and encouragement to all troops in the operation.

Military Medal

23659685 Corporal (acting Sergeant) Ian Roderick SCOTT, Corps of Royal Engineers.

On the morning of 30th May 1967 Sergeant Scott was in command of the leading group of a convoy moving down the Wadi Matlah, South Arabia. At about 0815 hours the vehicles ran into a strong dissident ambush and came under heavy fire from rockets, machine gun and small arms fire. Both the leading vehicle and Sergeant Scott's vehicle were hit and many casualties were sustained by the men as they dismounted to take up fire positions.

Although under heavy fire from only 30 or 40 yards distance, Sergeant Scott first called the roll to establish who was wounded, then organised the men so that they could bring effective fire to bear. Six men were lying injured and two men were killed in an area swept by heavy fire. Sergeant Scott personally assisted the wounded to a safer area and administered first aid. After helping one seriously injured man to safety he was himself wounded.

For about twenty minutes he, with one other unwounded soldier, kept up a continuous fire at any enemy who moved. After a lull in the firing a dissident group attempted to assault their position, one reaching the road. This assault Sergeant Scott and his companion beat off. Then regardless of his own safety he made his way to the radio vehicle which was in an exposed position, only to find that the radio had been damaged. Though pinned down by enemy sniping he returned the fire and contrived to encourage his men and the wounded, until reinforcements arrived to drive the enemy back; this being accomplished some two hours after the ambush was sprung. It was not until he returned with the remainder of his troop to the unit base, that he,

revealed that he himself had been wounded in the chest and arms as a result of which he had to be evacuated.

By his coolness and presence of mind and by showing great personal courage and initiative Sergeant Scott was an inspiration and an outstanding example to his men, and displayed leadership of the very highest order. His actions undoubtedly saved the lives of some of his comrades.

Military Medal

23916403 Corporal Ronnie BRADLEY, Prince of Wales's Own Regiment of Yorkshire.

Corporal Bradley has served as a Section Commander in the Reconnaissance Platoon of the 1st Battalion The Prince of Wales's Own Regiment of Yorkshire for over two years. He arrived, with his section, in Aden on 28th June 1967, for his second tour of anti-terrorist operations within two years. Immediately he took every opportunity to get to grips with the hidden terrorist. Frequently he did this by deliberately offering himself as a target to draw the enemy into ambushes.

On the night of 16th July 1967, an ambush was laid for a notorious terrorist in No. 4 Street, Tawahi, in the area of "grenade" steps. This is the area from which large numbers of grenades have been thrown at security forces. Corporal Bradley volunteered to act as bait for this ambush. He drove his vehicle up and down the narrow back street at night past the danger spot, time and time again. The terrorist, that night, did not rise to the bait.

The next day Corporal Bradley's section was engaged on a mobile anti-terrorist patrol. At 1104 hours, near the Tawahi Market Place, two pistol shots were heard. Corporal Bradley deliberately led his section into the area although he knew that such shots had in the past been fired to lure security forces into an ambush. His approach was skilful and made at speed. As his vehicle broke cover a grenade was thrown. Corporal Bradley ordered his crew to take anti-grenade action. As he had seen the terrorist he did not go to ground himself but remained exposed to the blast of the grenade in order not to lose sight of the fleeing terrorist. He then personally, shot, wounded and captured the terrorist.

On 8th August 1967, Corporal Bradley was once again on patrol in Tawahi. He saw from his vehicle an Arab acting in a suspicious manner. He dismounted and approached the man with the intention of questioning and searching him. The man turned and fled. Corporal Bradley gave chase. As the fleeing man rounded a corner he threw a grenade at Corporal Bradley. Once again, ignoring the danger from the grenade, Corporal Bradley continued to chase the terrorist and finally captured him single handed.

By these actions he has shown personal bravery and has demonstrated a standard of alertness and an aggressive spirit of the highest order. His leadership and example has contributed much to the success and efficiency, not only of his own section, but of his platoon and battalion.

Military Medal

24026634 Private Philip DAVISON, The Prince of Wales's Own Regiment of Yorkshire.

Private Davison of the 1st Battalion The Prince of Wales's Own Regiment of Yorkshire has served in Aden on two anti-terrorist operational tours, from September 1965 to September 1966 and from 27th June to 1st October 1967.

During the latter tour he has been a radio operator in a section of the Reconnaissance Platoon. His operational tasks have necessitated him operating on foot and mobile patrols continuously, with little or no respite, in the dangerous back streets and alleys of Tawahi. Whilst performing these duties with his section he has been subjected to thirteen grenade attacks. In the course of these attacks four members of his section of seven have been wounded including Private Davison himself, who has been wounded twice.

When wounded on the first occasion, he remained with his radio and refused medical attention until he had passed the necessary report to set retaliatory action in motion.

At 1100 hours on 30th September, his mobile section was the target for a double grenade attack. Private Davison, who was observing to the rear of the patrol at the same time as operating his radio

set, saw the grenades in the air and shouted a warning. This allowed the leading vehicle time to accelerate from the immediate point of attack and for the crew to obtain safety and to prepare for action to eliminate the terrorists. Private Davison himself dived for cover in the gutter but the two seconds delay caused by his warning shout resulted in him being caught in the blast of one of the grenades which landed only three feet from him. Although very seriously wounded and losing blood fast, Private Davison refused medical aid until he had briefed his patrol commander on the position from which the enemy attack had come and the subsequent movement of the terrorists.

Private Davison's resolution, disregard of personal danger and concern for the safety of his comrades were in the highest traditions of the service and comradeship.

Military Medal

23070741 Sergeant Roy DEWHURST, The Lancashire Regiment (Prince of Wales's Volunteers).

Sergeant Dewhurst is the Battalion Intelligence Sergeant. In this capacity he has for the last six months been continually on operations without a single day's stand-down and living for almost the whole of that time in the Tawahi area of Aden. On numerous occasions this area has been the scene of riots and demonstrations and has had many shootings and grenade incidents against security forces and civilians alike.

A total of 41 grenades were thrown at men of the Battalion during the six months of operations in Tawahi and of these, seven were thrown at Sergeant Dewhurst; two of them causing him slight injury and a third damaging his vehicle. Of the 23 shootings in the area two were aimed directly at him, in the more recent of which, a burst of automatic fire, actually ripped the front of his shirt from his chest. Never has he let these incredible escapes deter him and he has rarely failed to be the first man on the scene of an incident and taken charge in restoring order by organising the care of any casualties, rounding up suspects and assisting the civil police. His efforts to procure information have been untiring and he has worked far beyond the limit required for his appointment in an effort to provide useful and up-to-date intelligence. By day and night he has carried out numerous patrols and sorties into the back streets and "grenade alleys" where he has deliberately presented himself as a target to grenadiers and gunmen alike in order to make a kill or an arrest. In this he has been outstandingly successful and by his "live bait" methods at least three grenadiers have been captured and two shot.

His contribution to the intelligence organisation has been immense. He has shown a complete disregard for his own safety and his bravery has been of the highest order.

Military Medal

23796137 Corporal (acting Sergeant) Jack HUGHES, The Lancashire Regiment (Prince of Wales's Volunteers).

From February to August 1967, Sergeant Hughes was the Platoon Sergeant of 2 Platoon "A" Company, 1st Battalion, The Lancashire Regiment (Prince of Wales's Volunteers). For the first five months of the Battalion's emergency tour in Aden it was responsible for the maintenance of law and order in Tawahi. This entailed a considerable amount of patrolling of the town by day and night, particularly in the cramped and hostile slum area where the grenade is the favourite weapon of the terrorist.

On 3rd April, Sergeant Hughes was in charge of a vehicle patrol when he was grenaded for the second time in the day and was slightly wounded, as also were other members of the patrol. With quick presence of mind he led those who were unscathed to the spot from where the grenade has been thrown and arrested two suspects. He returned immediately to the area of the explosion and after seeing to the evacuation of the wounded allowed his own wound to be treated.

Sergeant Hughes was grenaded on a further four occasions, the last of which was on 2nd July when he was again attacked whilst leading a patrol in Tawahi. A member of the patrol saw the grenade being thrown but was unable to give sufficient warning to prevent Sergeant Hughes being wounded in the back. Completely undaunted, he rallied his patrol and gave chase among the huts, eventually catching some suspects. He refused to be evacuated until the terrorist responsible for the incident had been

identified and taken away. Only when he was sure that his men had been safely handed over to another Senior Non-Commissioned Officer did he agree to go to hospital to have his own wound attended to.

On 17th August, after the Battalion had taken over the hostile area of Al Mansoura, Sergeant Hughes was leading a foot patrol across some open ground when he came under heavy automatic fire. He deployed his patrol quickly in order to return the fire but whilst directing his men he was hit and badly wounded in the left arm and stomach. He would not allow his men to come to his aid, thus exposing themselves, until they had effectively dealt with the enemy and by that time he was in considerable pain and bleeding badly.

The determination and complete fearlessness that he has shown in all his actions has been similarly reflected in his battle for life whilst in hospital after his last wounding. His outstanding leadership, high sense of duty and unselfish devotion to his platoon have been of the highest order at all times.

Military Medal

23935360 Lance Corporal (acting Corporal) Robert John SANDERSON, The Lancashire Regiment (Prince of Wales's Volunteers).

During the night of the 19/20th of May 1967, Corporal Sanderson was in command of a patrol in the Al Mansura area of Sheikh Othman when he heard distant shots being fired which he correctly deduced were terrorist fire at the static posts of the Al Mansura Detention Centre. At this time he was some distance from the Detention Centre and in an unfamiliar area. However, despite the unfamiliarity of the ground and darkness he decided to deviate from his patrol route and try to ambush the terrorists. He therefore quickly rebriefed his patrol and with considerable speed and despatch moved into a position in rear of the terrorist firing point. To ensure that his ambush was in the correct position without making the enemy aware of his presence was extremely difficult and involved him in danger during reconnaissance.

Nevertheless, he soon had his ambush positioned and was in time to see two men approach from the direction of the enemy firing point. Quietly and skilfully he and his patrol lay low until the men were in the trap. Corporal Sanderson then exposed himself and gave the normal correct challenge. He was immediately fired upon by one of the men who turned and ran. Corporal Sanderson calmly and deliberately gave a fire order and one man was shot dead. The other immediately surrendered.

Corporal Sanderson's actions and skilful handling of his patrol undoubtedly eliminated two extremely dangerous terrorists in an area where one mistake may have resulted in the death or injury of innocent persons. To ensure he had the right men Corporal Sanderson deliberately exposed himself to the enemy and their fire.

In this action Corporal Sanderson displayed outstanding professional skill and a complete disregard for his personal safety without which the operation could not have been successful.

Military Medal

23233052 Sergeant Joseph HARKINS, The Argyll and Sutherland Highlanders (Princess Louise's).

Sergeant Harkins was the platoon sergeant of 13 Platoon D Company, 1st Battalion Argyll and Sutherland Highlanders. He arrived with the Battalion in Aden at a time when British troops had been driven out of the Crater District and occupied only the high ground around the town.

During the re-entry into Crater on the 3rd and 4th July 1967, Sergeant Harkins' platoon were given the task of spear-heading the Company night attack along the main axis into the heart of the town. The only information available on the enemy was that they were numerous and well supplied with arms and ammunition. Regardless of this uncertainty, the platoon carried out its attack with precision and efficiency and the opposition melted away with only token resistance.

The platoon objective, the Government Primary School, was a large stone building with exposed balconies and corridors, overlooked on all sides by other buildings in Crater. Throughout the first and subsequent nights Sergeant Harkins directed the security measures necessary to hold the position against attack. Windows were barricaded, walls mouse-holed and weapon positions constructed. A

vigorous and sustained patrol programme was put into operation. All these tasks were organised and supervised with a professional precision that have characterised Sergeant Harkins' every action.

On 26th August, Sergeant Harkins was commanding a patrol in a Saracen armoured personnel carrier operating in the notorious Bazar area of Crater. Here the streets are narrow, punctuated by alleyways and offering a perfect refuge for the terrorist gunman and grenadier. A grenade was thrown at a four-man patrol of another company. Two members of the patrol were injured, one of them the radio operator. Two local nationals were killed by the explosion and a further three wounded.

Within seconds Sergeant Harkins had dismounted his patrol and raced to the scene of the incident. Indifferent to the risk of further attacks against himself and his patrol, he organised the cordoning of the area, the rounding up of suspects and the prompt treatment of the shocked and wounded men. His timely and accurate reporting over the radio brought reinforcements to the area. This enabled vigorous follow-up action to begin, which resulted in the shooting of two terrorists.

In the subsequent anti-terrorist operations in Crater up to 18th September, Sergeant Harkins stood out as a Non Commissioned Officer of outstanding drive, resource and physical courage. Although exposed continually to attack by small arms, hand and anti-tank grenades, his aggressive reaction and high professional standards resulted in the complete domination of his platoon area and a steady toll of terrorists. In every aspect of his job his courage, energy, cheerfulness and devotion to duty were a continual inspiration to those around him; which has been reflected in the high standards and success of his platoon.

Military Medal

24033909 Lance Corporal James McAdam DUNCAN, The Parachute Regiment.

On the morning of Thursday, 8th June 1967, Lance Corporal Duncan was in command of the second Land-Rover of a mobile patrol of the First Battalion, The Parachute Regiment, travelling between Sheikh Othman and Mansura. Without warning they were fired upon by an automatic weapon from Section B, Sheikh Othman. Private McKinney, a general purpose machine gun gunner, who was standing in the back of the vehicle was wounded and the vehicle was immobilised. A second automatic then opened fire from a tall house which dominates the road. This fire, which entered the back of the vehicle, wounded Private McKinney for the second time.

When Lance Corporal Duncan, who had leapt out of the vehicle when it was immobilised, realised that Private McKinney was lying wounded and trapped in the Land-Rover, immediately returned and tried to get him out. He made repeated efforts but on each occasion was driven back by enemy fire. When all attempts had failed, Lance Corporal Duncan crawled back and managed to get a dressing on to Private McKinney's wound and held it there until help arrived and he could be evacuated. Subsequently over twelve bullet holes were found in the Land-Rover.

Lance Corporal Duncan's courage, determination, and devotion to a wounded comrade, in the face of accurate enemy fire, was in the highest traditions of the British Army.

This young Non Commissioned Officer's example inspired everyone in the patrol and his action prevented Private McKinney losing a considerable amount of blood and undoubtedly saved his life.

The QUEEN has been graciously pleased to approve the following awards in recognition of gallant and distinguished service in South Arabia.

Distinguished Flying Cross

Flight Lieutenant David Patrick MALIN (607723), Royal Air Force.

Flight Lieutenant Malin was the Senior Flight Commander of one of the two fighter ground-attack squadrons at Khormaksar, from July 1965 to November 1967. For the last two years, these two squadrons, and the fighter reconnaissance flight at Khormaksar were engaged continuously on operational flying. During this period, tasks involved preplanned strikes against arms caches and dissident bases in the hinterland of South Arabia, close support for British and South Arabian troops under fire, numerous escorts, and air defence patrols along the border with the Yemen. The results achieved were outstanding. In every case when ground forces were pinned down by hostile fire and called for Royal Air Force support, the attacking Hunters inflicted very heavy casualties—up to 75 per cent. of the forces involved. Preplanned strikes on pinpoint targets were carried out with the highest degree of skill and accuracy, on targets which were often no more than a single house, a narrow cleft in a wadi, or the mouth of a cave. The overall effect was virtually to eliminate ambushes and attacks on friendly forces during daylight and thus materially to reduce the military casualties that would have been suffered. These sorties were carried out in the face of active opposition from the ground and during the period, nine Hunter aircraft were hit by small arms fire, one being destroyed. He displayed outstanding qualities in the air, especially on operational sorties, when he frequently led strikes against a variety of hostile targets, coming under small arms fire but always pressing home his attack. On the ground, his leadership was of an equally high standard and was instrumental in passing on his accumulated knowledge to the younger and less experienced pilots in his flight. During a changeover of Squadron Commanders Flight Lieutenant Malin was a tower of strength and largely responsible for maintaining the operational efficiency of the Squadron at a high standard during a difficult period. The achievements of Strike Wing were of the highest order and earned the admiration of both the British and South Arabian Armies. Flight Lieutenant Malin was an outstanding leader and a skilled and deliberate pilot.

Air Force Cross

Squadron Leader Stanley HITCHEN (3519412), Royal Air Force.

Squadron Leader Hitchen commanded No. 84 Beverley Squadron at Khormaksar, from October 1966 to November 1967. During his tour he was

personally involved in virtually every operational Beverley task of any magnitude as well as giving the lead in flying a multitude of mundane short range transport support and supply sorties to every up-country strip in South Arabia, which were the stock in trade of his Squadron. He consistently showed most creditable initiative and high standards of leadership, both in the air and on the ground; this resulted in his Squadron giving better air support and higher aircraft achievements than ever before. Through his enthusiasm, drive and inspiring leadership in the air, he lifted the morale of his Squadron to the highest levels and earned it the reputation of being a highly effective operational unit. Typical of his work was when, as a Detachment Commander he organised and arranged a famine relief operation which was entirely successful; through his determination and enthusiasm the task was completed ahead of schedule and a greater load was lifted. He was also Detachment Commander on the highly successful air evacuation of the up-country strip of Mukairas, when the final Royal Air Force forces and supplies had to be removed at short notice under the threat of dissident and enemy fire. At Riyan, he was again responsible for a thoroughly successful air evacuation of the Station, made under difficult political limitations and considerable local tension. In all respects he showed verve, judgement and great flying skill in all the flights and operations which he personally undertook or was responsible for; many of these, when landing or departing from South Arabian up-country strips, involved him being under sporadic fire or the constant threat of it. His outstanding leadership, high courage and spirit in the air notably contributed to the success of the many operational tasks and missions flown for Middle East Command.
