Notice is hereby given that the Belper Rural District Council, in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, on the 28th day of October 1967, made an Order entitled the Belper Rural District (No. 1) (Shipley) Smoke Control Order, 1967, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.
