PUBLIC HEALTH ACTS AND CLEAN AIR ACT

BARNESLEY COUNTY BOROUGH

The Barnsley Smoke Control Order No. 6, 1967

Notice is hereby given that the Council of the County Borough of Barnsley in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 9th January 1968, made an Order entitled the Barnsley Smoke Control Order No. 6, 1967, declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order has been submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by virtue of section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence, and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st March 1969, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Town Hall, Barnsley, at all reasonable times during the period of 6 weeks from the 10th February 1968.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1. object to the confirmation of the Order.

SCHEDULE
