TOWN AND COUNTRY PLANNING ACT 1962

Birkenhead

The Minister of Transport hereby gives notice that she proposes to make an Order under section 153 of the above Act to authorise the diversion of a length of footpath off Arrowe Park Road, Birkenhead to enable development consisting of the construction of a hospital to be carried out by Liverpool Regional Hospital Board.

The proposed Order will require that the new length of footpath which the Liverpool Regional Hospital Board has agreed to provide as the diversion is to be a highway maintainable at the public expense, for which the highway authority is to be the Birkenhead C.B.C.

During 3 months from the 10th February 1968 copies of the draft Order and the relevant plan may be inspected at all reasonable hours at the Birkenhead C.B.C. Offices, Town Hall, Hamilton Square, Birkenhead, and may be obtained free of charge from the Ministry of Transport (quoting HLL 70/137/03) at the address stated below.

Within the above-mentioned period of 3 months, any person may by notice to the Minister of Transport (Ref. HLL 70/137/03), St. Christopher House, Southwark Street, London S.E.1, object to the making of the Order.

Bolton-le-Sands, Lancs

The Minister of Transport hereby gives notice that she has made an Order under section 153 of the above Act entitled "The Stopping up of Highways (County of Lancaster) (No. 1) Order 1968" authorising the stopping up of footpath No. 13, off Mount Pleasant Lane, Bolton-le-Sands, Lancs, and requiring the provision of a new footpath.

Copies of the Order may be obtained, free of charge, on application to the Ministry of Transport, St. Christopher House, Southwark Street, London S.E.1 (quoting HLL 70/20/289), and may be inspected at all reasonable hours at the Offices of the Carnforth U.D.C., Market Street, Carnforth.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 8th February 1968,
