**SCHEDULE**

*Length of road at Horndean in the Rural District of Petersfield*

Lovedean Lane, from a point 100 yards south of its junction with Coldhill Lane southwards for 688 feet.

NOTE. This length of road forms part of a longer length of road subject to a 30 m.p.h. speed limit imposed a number of years ago by reason of the existence of street lighting. The street lighting has since been altered so that, over the length of road the subject of the proposed Order, there is no longer a legal speed limit, although the existing speed limit signs covering the longer length remain in position.
