Notice is hereby given that the Mayor, Aldermen and Burgesses of the Borough of Accrington in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, on the 1st February 1968, made the above-mentioned Smoke Control Order, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the limitations and exemptions pro-vided by the Order and by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding $\pounds 10$ unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity. If confirmed, the Order will not come into operation before the 1st November 1969, or before such later date as may be determined by the Minister of Housing and Local Government.

SCHEDULE

The Borough of Accrington No. 8 Smoke Control Order 1968, relates to the area delineated to the west by a line along the centre of Electricity Street to its junction with York Street; along York Street in an easterly direction to its junction with the back street of 1 to 33 Pansy Street South; northerly along that back street to its junction with Eccles Street; easterly along Eccles Street to its junction with the back street of 69 to 95 Westwood Street; northerly along that back street to its junction with Lancaster along that back street to its junction with Lancaster Avenue; westerly along Lancaster Avenue to its junction with Pansy Street North; northerly along Pansy Street North to its junction with the back street of 119 to 127, Queens Road West; easterly along that back street to its junction with Westwood Street is portherly along Westwood Street in junction Street ; northerly along Westwood Street to its junction Street ; northerly along Westwood Street to its junction with Queens Road West ; easterly along Queens Road West to its junction with Whalley Road and thence northerly along Whalley Road to its junction with the Borough boundary. In the south the line then follows the centre of Hyndburn Road in a westerly direction to its junction with Electricity Street.
