- (a) to revoke part of The County Borough of Bournemouth (Dean Park Road) (Prohibition of Waiting) Order, 1964, as amended;
- (b) to prohibit vehicles waiting between the hours of 10 a.m. and 7 p.m. in the lengths of road specified in the First Schedule hereto; and
- (c) to prohibit vehicles waiting at any time in the length of road specified in the Second Schedule hereto.

The Order which will come into operation on the 7th day of March 1968 contains the customary exemptions for loading, unloading, boarding, alighting and certain other necessary purposes.

- (b) to prohibit vehicles waiting between the hours of 10 a.m. and 10 p.m. in the length of road specified in the Second Schedule hereto from the 1st day of June to the 30th day of September in any year;
- (c) to prohibit vehicles waiting at any time in any of the lengths of road specified in the Third Schedule hereto; and
- (d) to revoke The County Borough of Bournemouth (Richmond Hill) (Prohibition of Waiting) Order, 1963.
