prohibit waiting in the following length of (2) road on the north side on even dates and on the south side on odd dates and to limit waiting to 60 minutes in any 2 hours upon the side of such length of road upon which waiting is permitted:

York Avenue east of the easterly palisade line of Brighton Avenue.

(3) limit waiting between the hours of 8 a.m. and 6 p.m. in the following length of road to 60 minutes in any 2 hours:

Victoria Road West the short length of road on the north side lying between Brighton Avenue and the commencement of the existing limited waiting zone at a point 174 feet west of Cleveleys Avenue.

The usual exceptions are contained in the Order to permit persons to board or alight from vehicles, to enable goods to be loaded on to or unloaded from vehicles, and to enable vehicles to be used in connection with building operations, road works, funerals, or the removal of any obstruction to traffic.

Existing traffic regulation Orders are revoked so far as is necessary to give effect to the provisions contained in the above Order which also includes various consequential amendments of the existing Orders. The Order will come into operation on the 1st

April 1968.
