EXETER CITY COUNCIL

City and County of the City of Exeter Civic Amenities Act, 1967

Designation of Conservation Areas

Notice is hereby given that the Exeter City Council, as local Planning Authority, have designated certain areas of the City as "Conservation Areas" under section 1 of the Civic Amenities Act 1967.

The object of such designation is to preserve the character or appearance of areas of special architectural or historic interest, as distinct from individual buildings, to control development in such areas and to stimulate and encourage measures to improve the environment.

The areas designated are as follows:

- (i) *Cathedral Close*—the area bounded by Catherine Street, Chapel Street, the City Wall, South Street, the western boundary of The Deanery and Three Gables, the north-western boundaries of the properties in Cathedral Yard, to and including the Ship Inn in Martins Lane.
- (ii) *Southernhay*—the area bounded by the City Wall, Post Office Street, Southernhay West to Dix's Field, the northern boundary of Chichester Mews, the eastern boundary of No. 6 Barnfield Crescent to Barnfield Road, the eastern boundary of Nos. 25-40 Southernhay East to and including part of the Royal Devon and Exeter Hospital and across Trinity Street to the City Wall.
- (iii) *Topsham*—the area bounded on the western side by the River Exe, across Ferry Road to and along the northern boundary of the properties in Follett Road to High Street, along the northern boundary of Broadway House to Station Road, and the eastern boundary of the properties on the eastern side of Fore Street, including certain properties in Underhill Terrace, Majorfield Road, Victoria Road and Globefields, to and along the southern boundary of the disused railway line across Monmouth Street, Higher Shapter Street, Lower Shapter Street and along the eastern boundary of the properties in The Strand to the River Exe.

Plans showing the areas are available for public inspection at the office of the City Planning Officer, Trinity Court, Southernhay East, Exeter, during normal office hours.
