The County of Leicester (Carey Hill Road Stoney Stanton) (Traffic Regulation) Order, 1968

Notice is hereby given that on the 7th February 1968 the Leicester County Council made an Order under the Road Traffic Regulation Act, 1967 the effect of which is:

- (1) to prohibit, subject to the usual exemptions (including an exemption to enable goods to be loaded on to or unloaded from a vehicle), the waiting of vehicles at all times in the length of road specified in the first column of the First Schedule to this notice on the sides of road specified opposite such length in the second column of the said Schedule.
- (2) to prohibit the driving of vehicles on the length of road specified in the first column of the Second Schedule to this notice otherwise than in the direction specified opposite such length in the second column of the said Schedule.
