Notice is hereby given that on the 6th February 1968 the Council of the County Borough of Bournemouth made an Order under sections 1 and 2 of the Road Traffic Regulation Act, 1967, the effect of which is:

- (a) to prohibit vehicles waiting between the hours of 10 a.m. and 7 p.m. on both sides of Michelgrove Road from its junction with Boscombe Cliff Road in a southerly direction to its junction with The Marina;
- (b) to prohibit vehicles waiting between the hours of 10 a.m. and 10 p.m. during the months of June to September (inclusive) in any year on both sides of Michelgrove Road from its junction with Boscombe Cliff Road in a northerly direction to its junction with Percy Road; and
- (c) to revoke The County Borough of Bournemouth (Michelgrove Road) (Prohibition of Waiting) Order, 1963.
