The Northampton New Town (Designation) Order 1968

Notice is hereby given that the Minister of Housing and Local Government, in exercise of his powers under section 1 of the New Towns Act 1965 and of all other powers enabling him in that behalf, on the 14th day of February 1968 made an order designating as the site of a proposed new town an area of land of approximately 19,952 acres, as shown on the map referred to in the order and comprising the whole area of the county borough of Northampton and parts of the rural districts of Brixworth, Northampton, and Wellingborough in the administrative county of Northamptonshire.
