*Lengths of Road in the City of Worcester*

1. Both sides of that length of Britannia Square from its junction with Upper Tything to its junction with Britannia Road;
2. Both sides of Britannia Square from its junction with Back Lane South-Britannia Road for a distance of 130 feet in a northerly direction;
3. Both sides of Back Lane South from its junction with Britannia Square and Britannia Road in a westerly direction for a distance of 45 feet;
